Forum Restrictions and Orderly Conduct of Business. The Library Board of Trustees conducts the business of the Washoe County Library system and its citizens during its meetings. The orderly, efficient conduct of the meeting is integral and necessary to allow the Board to conduct business. The Chair or presiding officer may order the removal of any person whose statements or other conduct disrupts the orderly, efficient or safe conduct of the meeting. Warnings against disruptive comments or behavior may or may not be given prior to removal. Examples of disruptive conduct include, without limitation, yelling, stamping of feet, whistles, applause, heckling, name calling, use of profanity, threatening use of physical force, or any other acts intended to impede the meeting or infringe on the rights of the Library Board of Trustees, staff, or meeting participants. The viewpoint of a speaker will not be restricted, but reasonable restrictions may be imposed upon the time, place, and manner of speech. Irrelevant and unduly repetitious statements and personal attacks which antagonize or incite others are examples of speech that may be reasonably limited.

<u>Public Comment.</u> Public comments are welcomed during the Public Comment period at the beginning of the meeting for all matters, whether listed on the agenda or not. Additionally, public comment specific to the action item being considered will be heard during individual action items on the agenda. Public Comment is limited to three (3) minutes per person. Persons may not allocate unused time to other speakers. During the "Public Comment" items, anyone may speak pertaining to any matter either on or off the agenda. Anyone wishing to provide live public comment may do so in person, or by teleconference by logging onto the Zoom webinar by accessing the above link. To provide public comment via Zoom, log into the meeting at the above link and utilize the "Raise Hand" feature during any public comment period. Additionally, persons are invited to submit comments in writing by emailing The County will make



reasonable efforts to send all email comments received by 4:00 p.m. on the business day before the meeting to the Trustees prior to the meeting.

Response to Public Comment. The Board can deliberate or take action only if a matter has been listed on an agenda properly posted prior to the meeting. During the public comment periods, speakers may address matters listed or not listed on the published agenda. The Open Meeting Law does not expressly prohibit responses to public comments by the Board. However, responses from the Board members to unlisted public comment topics could become deliberation on a matter without notice to the public. To ensure the public has notice of all matters the Board will consider, Board members may choose not to respond to public comments, except to correct factual inaccuracies, ask for Staff action, or to ask that a matter be listed on a future agenda. The Board may do this either during the public comment item or during the following item: "Board Comment – limited to announcements, strategic plan activity updates, or issues proposed for future agendas and/or workshops."

- 2) Public Comment –Three-minute Time Limit Per Person [Non Action Item]
 - 1. Andrew Maurins: Spoke on his opposition to put programming for the library on someone else and not the Librarians who workday to day to make the programs work. Not a good move for the library or the community.
 - 2. Gail Townsend: Spoke about how there needs to be more control in the meetings.
 - 3. Nasim: spoke about the changes being proposed to the bylaws.
 - 4. Stacy Spain: Would like to keep the programming in the libraries and have the librarians continue to process the programming.
 - 5. Bruce Parks: Spoke on his request and denial to make a presentation on the constitution.
 - 6. Drew Ribar: Spoke on repression of the press and constitutional rights in libraries. He is running for office to hopefully make a change.
 - 7. Jessica Munger: Wanted to know why some LGBTQ people did not want to come to the

table and talk over the conversations going on in the libraries.

- 8. Valerie Fiannaca: Wanted to know how many activities the library had set up for Memorial Day or for the Fourth of July. Has made several requests for these to appear as a program.
- 9. Alana Fitzgerald: Spoke on her disappointment about the meeting being held during business hours making it difficult for the public that work to attend the meeting. Spoke against her belief of censorship and inappropriate materials not being moved.
- 10. Kate Withfield: Thanked Director Scott and library staff for their outstanding job with the library's mission which is to connect people with information ideas to support and enrich and engage the community.
- 11. Candace Powel: Spok on support for the library and that it is difficult to make meetings that are held during the day.
- 12. Kate Salim: Spoke on the item that recommends the meeting location be changed. She feels this would be a great disservice to the public and the libraries. Spoke about the March meetings being cancelled and reasons why they were cancelled. Would like to continue to see the meeting held from 3pm on so the working public that work can have an opportunity to attend the meetings.

3) Board Comment [Non-Action Item]

Trustee Moser would like to do some investigation into board committees. Perhaps further information on self-evaluation for the Director. Needs a clear delineation on what issues and topics we need to work on in communities that we are not getting through during out meetings.

Trustee Rogers also spoke about his dislike of the meeting taking place at 10am as opposed to the evening as usual.

Trustee Silver Requested that the attorney's office train the board on open meeting laws. Feels the board would benefit from the training. Second would like clarification from the attorney on whether we the Trustees has authority over programming because as she reads the responsibilities of the board it is not for the Trustees to decide.

Trustee Silver also spoke on how the meeting should be kept from 3pm and on.

Bruce Parks: Back in November he requested an appeal to the decision of the board for the minutes and would like to see his appeal on the next agenda for the next meeting.

Gail Townsend: Her name is constantly misspelled in the meeting minutes. In January her name appeared on a comment made by another person and not her. Not sure what the policy is to ask for corrections or whether they can be made.

6) New Business

a) Discussion of the current process utilized for approval of a library program or event [Non-Action Item]

Director Scott presented a power point presentation to the board regarding the process for library programming. Beginning shows how the programs are put together. There is a committee that will decide which programs and events are appropriate which is consistent with the library strategic plan. This is a several month process which includes public surveys, public forums and other feedback from staff.

Trustee Moser asked Director Scott how one become a partner or affiliate for the library. How can affiliates get in touch with the board so we can support that in the future.

Director Scott responded that the service and library events team will do the outreach to different events and different programs we have been partnering for years. Most are educational institutions or programs that assist children and seniors which go hand in hand with the coordination.

June is the review process for the schedule. June is also when the bylaws are reviewed. There will be a policy put in place and brought back to the board for review. Staff create the library policies. The board would review and oversee the policy.

Barry Barnes

I am and have been a user of libraries for 75 of my 90 years. I started reading when I was four. I love to read. I read thousands of books from libraries and have hundreds in my own home. I think it's great for parents to monitor what they could children see, and my wife and I did the same when our girls were young. I also know that as kids age, they are exposed to all sorts of things whether the parents like them or not and the way to prevent their children from having bad influences is to be good models for your children create good values for them and model those values at all times. We were certain all of our lives that is our moral and legal think certainty does not impose our values from other people and that it's important for other people to understand that when a minority tries to impose their values on other people it leads the way inevitably to despotism and despotism starts as a corrupt leader who tries to lead a minority to impose the rights on others. Jessica Monger

It's really good to see everybody here. Good evening trustees and fellow community members my name is Jessica. I'm a Reno resident voter activist organizer and parent of a young child who absolutely loves books and sometimes eats them as well. I'm also the program manager for Silver State equality Nevada's largest LGBTQ plus civil rights organization. Public libraries are an incredibly important third space. In case you're not familiar, third spaces are locations that facilitate social interaction outside of the people who live or work with and encourage public relaxation. They are places where you encounter frequenters of a space as well as potential new connections. They're places of community exchanges and free thought and access to wide range of information. They're also places where you can go and be in community without being pressured to spend money. We don't have a lot of third spaces in our communities anymore. Libraries are where anyone can come and learn about anything and they should be places where everyone in our community can see themselves represented. On a personal note I live in a family I'm in a family with two moms we're a same-sex couple and we have a young child and we work and learn and thrive here in Reno and we care about our community and it's important that when we show up at the library we see books that depict families like ours. There are some in this room who would call books that depict families like ours pornographic. I've heard that said here to be honest that says a lot more about you than it does about us but



that's another conversation. To us it feels good to take our kids to the library to the children's section and pick up a book to see families with two moms or two dads or gender diverse people. I digress a bit as my main point here tonight is a thank you thank you to the trustees who sit through long meetings to hear your community caring loudly at you and thank you to the Librarians who help us find the exact right board book for children about their specific favorite animal of the week and thank you to director Jeff Scott who seems to understand that libraries aren't just for one kind of person one religion one kind of family but that should be a reflection of our community which is diverse and colorful and beautiful. I know you often hear loud volatility and hostility but tonight I hope you hear that those voices are not actually the majority most of us love the library Love Freedom of Information love to challenge ourselves and read things outside of our own life experience. hi baby and where was I. good evening my name is Kristen Lewis I'm a teaching professor at ugr in the department of physics a mother of two one a queer team I'm speaking tonight in support of the library and its support of our diverse Community I grew up in the neighboring small town of loyon my father commuted toino for work and I know that in the early days my mother my brilliant National Merit and presidential scholar mother felt isolated in a small town with tiny kids but she never let our world be small and when you don't have much money when you're um when you're culturally cultural exposure is narrow due to geography the means to Wi your world books specifically library books we took advantage of a Good Neighbor policy to borrow from the wasow County Library System even now as a middle adult I can close my eyes and remember the feeling that I would get standing in the young adult section of the north Valley's Branch it was the feeling of possibility later when I became a young mother with a PhD and two toddlers who seemed not at all impressed by my education I knew just where to take them we went weekly to Library story time and events we completed summer reading challenges and Community read alongs for a three-year-old with the help of a librarian I once checked out every single picture book we could find on tractors nine twack books there is power in stories in information in connection to community these Library resources remind us of our personal value and expand our personal possibilities and it is that possibility that brings us here tonight at its simplest today's conflict is the intersection of Hope and fear there is hope in the notion that all people can have free access to information and education the central mission of libraries is one of democracy the centors would have our Community Driven instead by fear not coincidentally the foundation of authoritarianism where we hope that all young people in our community will value themselves exactly as they are those who would protect them from diverse content in fact just don't want every kind of person to feel value we are hopeful that these young people confident and educated will grow to be an asset to their Community we know that their very diversity of belief ability disability race culture sexual orientation and gender identity is one of their strengths and therefore one of ours those who would remove the Mir of B diversity from the collection and events posted by the library are simply fearful of those they consider other to those driven by fear I would sincerely and without malice recommend that you read a book and to the library trustees I want to be counted among the hopeful and reiterate the overwhelming support this community has for the current mission of the was County Library thank you

thank you to the library board members um I've been using L County libraries for 20 years but 16 years ago they became extremely important to me because I had one and then two little kids and the highlight of our week was to come to Library story time every week and that was where we saw our friends that was our third space was also where we ended up with a pile of books that we brought home every week and that's been um constant um in our lives for the past 16 years um The Librarians who gave Story Time were like total rock stars to the kids if they ever spotted one of those Librarians like Miss Judy just in his backs working it was like a major celebrity signing for them um Librarians are such important people in their eyes um a few years later I found myself homeschooling for five years and the library became more important for us



um we were using Library materials one of my kids has a learning disability and uses audio books which cost a fortune but we were able to just get them all free through the library system we used the study rooms at the Northwest library and we came here a lot to the children's section of the downtown library that had just been remodeled and was such a beautiful and the welcoming space where weent time um during the pandemic again the library was our um we off because we were downloading digital audio books and ebooks and that was what got us through that time um both of my kids in their own way became uh book rooms they're constantly reading and listening to books and gradually I realized that they actually have a much larger world view than my husband to I'm 51 and as a kid the first books did not exist the books that my kids have gotten from the L County library system are about people who are different from them who have different life experiences and come from different places and because they had the opportunity to read these books they understand the world better than we do they're actually able to educate us in many cases um and that to me is the value of diverse books um one of my kids is now a library volunteer she's an older teenager and the first day that I dropped off to volunteer I had a memory that was so strong of carrying her into the F library to Story Time and the fact that she's working now alongside some of the same Librarians that she otherized when she was a toer just means a lot to me and her and she's actually interested in becoming a writer and in studying Library science and being librar so that's the effect that the libraries who had on life and I can't emphasize enough um the value of diverse books in Reading widely and the influence that that has on kids thank you thank you

Thank you trustees and thank you director scott my name is Stacy Spain and I am the executive director of our Center I have raised two kids here in was County who both loved the day they got their Library car my kids were huge customers of the library one of them is now in ourn and one of them is at UNR studying social work one of them is a s straight white guy and one of them is lesbian they both were exposed to lots of different kinds of books and that exposure helped them create their sense of self they are both awesome young adults whose lives were molded by our libraries in part on a professional level I work at our Center where our mission is to maintain a safe empowering and supportive center for the lgbtq community and allies that addresses advocacy education and services we seek to build connect and strengthen the lgbtg community Through Community Building arts and culture programming and inclusive activities we serve with special interests the most at risk in our community including our youth seniors and trained populations libraries are my Sacred Space space where anyone can come to learn and be curious grow and create change in their worlds I support the drag Story Hour program because it is literacy based and inclusive I'm going to switch gears just a little and quote some stats from the Trevor Project according to the National 2022 survey on lgbtq youth mental health 45% of lgbtq Youth ser seriously considered attempting suicide in the past year nearly one in five transgender and non-binary youth have attempted suicide and lgbtq youth of color reported higher rates than their white peers um as an elder queer myself I serve our youth when I work to support a community that includes programming that um looks to them as uh folks who are going to be here in our world with us long term um I think that when we are supporting a a program for smaller kids we are also showing our teams that we



support them it's important for us to have inclusive books and um a and a world view that includes a a broad cross-section of all of the folks that come into the library every day I hugely thank you for your service and I thank director Son thank you

I'd like to thank the members of the board for their incredible patience for today's meeting and the opportunity for us all speak today my name is Vita Gone I'm a resident of Reno we've lived here for the last five years be sure before that South Carolina in before that 20 years in Florida while I have been a citizen in this country since birth I was born in Venezuela my father is from and my mother was born in the United States my birth name is David as a transwoman and I have no shame that which some of you might the previous two states I mentioned South Carolina and Florida are not exactly the most welcome places.. is the first place that I live where I am safely allowed to be and public which is why the importance of diverse literature is important to me want to humanize to the general public and displays narratives that are super important to myself to hear that literature containing narratives similar to my own life are being challenged as pornographic and unsuitable for children it's just a step backwards for me to be able to be myself in public it is so Insidious to selectively read a section of a book and paint the entirety of the story folder and shamelessly lie just beyond insult things itself as it is true for all of us I was a kid a queer child unable to articulate my feelings unable to express who I am I would have given so much to have such Books available to me while I was in high school or middle school narratives uh that included Latin Fe team showing that my feelings were not an isolation but a shared experience instead I attempted suicide I frailed onto my life until I eventually found out this is who I am so to avoid having kids going through the bullying the harassment the beatings that I went through myself as a kid for being too a feminine for being different I would like to endorse personally the diversity in literature and as a Wast taxpayer you have go ahead to keep buying those books thank you

Candace pow I am a parent of croud Library card holder a northern and a business owner and an inspiring band book author I'm here to lend my voice in the unwavering support of our incredible libraries and as an ally to the Igbtqia plus Community today I'm here with my children we have attended many drag queen story hours around the country the accusations of trauma grooming and impropriety directed at drag queens story hours are actually inaccurate but they're misplaced it's not the drag queens who are at fault the perpetrators of such actions are the very individuals seeking to condemn these events this is a manufactured trauma some are seeing happens at these events on June 15th protesters who care so deeply for young children also spewed hate at my two and six-year-old children as we entered this library for Drag Story Hour at our favorite Library location this location my children were unnerved by scary people who violated their privacy these protesters violated my children's privacy by filming and photographing them without their consent my kids were frightened and I was and I still am very angry I given the pictures fortunately our library system was prepared with the wonderful



umbrella volunteers and my children quickly got into the welcoming environment that Miss Ginger Divine and our downtown library created my oldest was visibly relieved and once we were with Miss Ginger we said we're safe I've brought photos taken by the rgj of those individuals who harassed the children entering the library that day several are in this room today and out of courtesy to them I have censored their faces a courtesy they did not provide my children on June 15th devastatingly this Library location is now a place my children associate with fear and harassment my daughter asked if the man taking her photos was a kidnapper and if he would be here today he is and she wouldn't come up with me to speak I encourage the board to remind people that if these events don't align with their beliefs exercise Choice don't attend it's literally the most fun event you will ever be a part of I don't know what's better than drag queens and toddlers you're missing out I implore this Council to see this first for what it is and not allow this false narrative and manufactured chaos us dictate what our libraries stand for let us champion inclusivity and uphold diverse programming in our libraries this is a nurturing space where everyone is welcome thank you

Nim Jamia her I'm a local author and I've been a resident of Wshoe County for six years and a homeowner for one I regularly use the libraries offerings and have also been involved in library programing I'm here today to speak in favor of our library system at large specifically their inclusive collection and programming for me book bands and the attacks on libraries are personal I did not see myself in book until I was 21 years yet growing up the library was still a place where I could safely explore books that would later help me understand my gender and sexuality without judgment I volunteered for over six years there and it was also a space where my Muslim immigrant parents and my non-verbal autistic brother and I belonged I wish I had access to the books that are many people are arguing against the ability for libraries to curate a wide diverse collection of books and programming is vital for all of us Dr ring Sims Bishop coin DET termed Windows mirrors and sliding glass doors to describe the importance of inclusive literature that is books that books can allow readers to see their own lives reflected on the page mirrors give glimpses of lives different than their own windows and Foster empathy for people unlike them sliding glass Forest not only is it important for children to see themselves in books but for them to not see themselves to understand that their lives are but one way to experience the world this demonstratively leads to increased empathy for others which translates to De decreased violence against those deemed different violence can come in many forms and exclusion is one of them over 37% of Washoe County residents are non-whites the movement advancement project estimates that almost 6% of all Bevadans are feared it is our responsibility to make sure all of these individuals feel that the public library is also a space and resource for them watch County's assessment of their collection showed that 21% of their titles are considered diverse against the national average of 11% two of the Strategic goals for the w library for w County Libraries is to celebrate our diverse community and provide welcoming spaces a welcoming space is more than a readon entryway and new couches it's a frame of mind and approach to community building the libraries committment to these goals by having books



and programming that act as mirrors windows and doors is a necessity not only for marginalized people but for those who find themselves afraid to face experiences unlike their own please do not give into the fear that drives a vocal minority who would rather smash those mirrors windows and doors and take an opportunity to engage and Stu through please continue to allow Jeff Scott and his team to curate the was County Libraries as an inclusive space for all thank you

My name is thank your work I'm here to bring that issues many parents have concerning the watch of count school board and the photographic and explicit material that is available to Children the use of this material is say how to be children or Gro them for bizarre sexuality obscenity laws have been changed in many states to except liar public schools and universities so that allows questionable material to be legal it does no good to bring up obscenity laws because libraries public schools and universities are exempt from them but there is another way to look at this to measure the consequences of this material is there a higher standard Do no harm some materials do not pass this test you know why why would anyone want to groom a child using these materials that would infringe upon their innocence 43 states have passed of City exemption laws that eliminate inability associated with using these graphic materials if they are employed for educational purposes distribution of this material on school grounds or libraries would be considered criminal but exposing our children to it during Library hours is somehow being educational this means that someone who provides or older materials to a child will respondence in jail time for harming the child except when that person is a teacher or a librarian providing the materials in a public school classroom or Library over the years the concept of freedom of speech has expanded well beyond spoken or written words the courts have attempted to protect all men of self-expression throughout our nation's history however certain categories of speech have not been protected by the First Amendment which means government can limit the activity of sin he was not protected under the First Amendment rights to prestige violations of federal obscenity laws or criminal offenses it is time to protect our children thank

it's a science fiction book just for reference um that book taught me that I was experiencing child a child without that book without access to books with these difficult materials like child abuse I would never have learned that my parents were abusing my parents did things that make the passenger eight lady look like a saint and I would never know another book that has been just an incredible addition to my life uh was a profession's guy on how to eat Fire by Brian Bushwood he was actually inspired by Danette another person who wrote a different book on how to eat fire I can't the title that one but it's a real however this book depicts incredibly dangerous ass such as shoving you know Fuel and fire directly into your face and around your body but without this book I wouldn't have the career that I have today I read that book whenever I was 14 and 15 I learned how to eat fire and shut cotton balls on my M couple of months ago I went out and I learned how to blow fire in from there I'm a to march in Virginia City parade don't thank you

Gaia Brown uh 23 year resident of Reno I am a professional religious educator and a transexuality educator and I want to go back to when I was was probably about 11 years old and this would be in the 50s and my friend Mary and I were talking and came up with a bunch of questions between the two of us we couldn't answer they had to do with sex we knew nothing about it we went to her mom and she said let's go to the library and we got in her car and drove to the library and there we were found books that we were able to look at and have our questions answered it was a wonderfully empowering andent for Mary and me and it did not lead to sexual activity by the way now as an adult I find myself with a son-in-law who has a 17year-old transexual son this has been a real struggle for that family they're very devout Catholics they had struggled so hard but they've come down that they are going to be supportive of Noah now he's 17 but as he started his transition his siblings were three and N years old so these were little children but this is a family that needed support as they were trying to navigate a very very difficult difficult family situation and it's only when like that get support from organizations and Facilities like a library that they can muster the courage to do what they need to do to support their child so the library is a very important place for families and it's not that unusual now for families to have transexual children or gay children so thank you for having your materials the materials here available for families like this and just this was in the New York Times yesterday of um obituary for a 85-year-old transsexual psychologist and um this person uh her name was Jean Hof when she was asked uh what can we do to accept you this was back in the 70s she said it may not be necessary for you go to a lot of trouble to learn about accepting transexuals if you have a general principle and that is mind your own business so thank you very much for the work you do thank you



Mar Rodriguez for the record I am a mother and grandmother and writer I have visited libraries with my Senate when he was a child and my grandchildren when they were smaller and like everybody else here I love books I may mention that I am a first generation Mexican Liv in United States and I was raised in served Christian by my parents as much as I love books I don't love all books what I mean is not all books interest me there are books on subjects that I don't care about and there are writing styles by writers are subject matter that I don't care about just like everything else in art it is a matter of taste but just because I don't like them or agree with them does not mean want them off the shelves nor should I expect the library to remove books because I don't agree with it no one has the right to demand the library to remove vegan or vegetarian cookbooks from the library just because they eat meat just as no vegetarian or vegan has the right to demand that the library remove traditional cookbooks if they feel it is moral to no one has the right to demand the library to remove fantasy or faital story books or novels just because they don't believe in elves fantasy creatures or magic just someone who is a pacifist has no right to demand the library to REM books on Military strategy or War history no one has the right to demand that books about the Paranormal or life after death be removed just because they don't believe in the spiritual realm and no one has the right to demand that books about spiders or snakes or cats being removed because they have a phobia against them finally any more than someone of a religious faith has a right right to demand that holding books of a different Faith be removed does anyone have the right to demand that books about a lifestyle that they do not agree with be removed from the shelves and regarding books that are accessible to Children parents not the library are responsible for screening or selecting what their children read just as parents are responsible for what their children are exposed to on television or on the Internet the library allows parents at any time to go online and see what they are checking out we all have different interests and beliefs and we all have the right to read the books of our choosing not what someone else's beliefs our Conscience Says we can and just on a personal note the first disturbing and inappropriate thing that I read was in a book that was given to me when I was 14 years old by the church Minister people should read Genesis 19 if they want to see something truly inappropriate thank you

up hi my name is R um and I'm here to talk about protecting children uh so I was raised by fundamentalist Christian parents who would agree with the small group of people who are here attacking a library uh when I was the young queer person my parents Dy my sexuality and called my identity ful and mentally ill my parents tried to prevent me from reading books about people like me and so what I did was I went to the library and at the time I was depressed and suicidal because I thought I was by myself in this big scary world and the library is where I felt safe the library is where I felt not alone books with queer characters saved my life and libraries were where I found those books that saved my life I have a PHD in social welfare and I'm a professor researcher and therapist and my researcher my research is about how parents and other adult authority figures make decisions that harm Weir and trans kids parents can and do cause harm to Free's kids many of the people in this room would be terrible parents who Que in trans Kates some of them have even spoken today libraries have the power to keep brief libraries have the power to ensure that clear and Transat feel seen so as a researcher I I actually do know the statistics and I'm not going to quote numbers at you I'm just going to give you a brief rundown of the facts the facts that we know in science not in the Bible but in science and science tells us that queer and transgender kids have the highest rates of suicide of any known group of young people the highest rates and these rates are directly correlated with stigma and rejection they're directly correlated with kids feeling like they are alone because they don't feel seen because they were rejected by their parents we know that when queer and trans kids are affirmed and acknowledged and included their outcomes normalized with a general you population when que transs are treated as people they don't have highes of suicide anymore when quean trans kids are made invisible they die it's as simple as that when we reject queer identities



when we prevent people from seeing themselves in their communities kids die the stakes really are that high thank You



a) Approval of Minutes from the Library Board Meeting of November 15, 2023 [For Possible Action]

Public Comment

Reva Crump stated that the November minutes lack punctuation and coherence. She stated the draft minutes reflect poorly on this body She submitted to the director a type version of her public comment.

Gail Townsend stated that there's a comment wrongly attributed to one individual. She thanked the Board for keeping order in the meeting.

Bruce Parks stated that the minutes lacked attention to detail. He stated that it appears that comments from only certain people in those minutes had their message garbled. Claimed there is a pattern of discrimination within the Washoe County Library System for more than a year. The Board should use AI, but then go back and make edits to the draft minutes.

Willie Purchert stated that the criticism of the minutes is an orchestrated campaign to create a certain reality which people are trying to push their agenda. Stated he has no problem with the minutes from the last meeting.



Janet Butcher stated that commenters comments were correctly stated. The minutes should be proper and concise.

Public Comment

Valerie Fianacca asked how much more controversy are you going to put up with how far down the road can we go. Questioned whether it worth the liability for one program.

Cate Salim stated that Director Scott has always been very cooperative and helpful when she worked in the elections department. She spoke with Director Scott daily during early voting in 2020. Stated that she left her position in elections in 2022 mainly due to the negativity of this community and personal attacks. She received death threats, threats of violence, my name published on the internet. Stated that she loves the Libraries and the staff in the Libraries. She is very grateful to Director Scott for what he has done for our community. I know drag queen story hour is very controversial but it is there for a purpose for our kids that do want to attend.

Cliff Nellis questioned as to what happened to Director Scott in Berkley California, which he indicates is not a conservative town. Stated that the organization moveon.org is a far left organization that got Director Scott kicked out because he purged 39000 books and sent them to the Friends of the library and he had them burned. Believes that Director Scott is nice personally but he is a radical leftist and that is not what Washoe County should represent. States that the library needs someone new.

Gail Townsend stated that she has found Director Scott to be extremely organized and always has information ready. She feels that he represents the library to the community very well. I am a library patron that is in the library a ton with my five year old grandson. She hopes that the Board can work



cooperatively with Mr. Scott to advance the goals of the library. She believes that it would be ridiculous to remove Mr. Scott. Really want to commend Mr. Scott for supporting marginalized communities. He has been an excellent director.


Nichelle Hall stated that she has no personal issues with Jeff Scott. States that she was prevented from signing up online for a library event and the screen indicated that she was banned from attending library events. She stated that she received no notice of this. She stated that she feels discriminated upon. She encouraged the Board to take a look at the May 2018 minutes because in they show five women who worked for the library system spoke out against Mr. Scotts leadership style. She believes that there is a pattern of Director Scott's communication style that needs to be changed.

Charles Elliot stated that reviews are for Boards and management to look back and analyze how things are going. Thanks the Board members for listening to all of the comments and their commitment. Stated that he doesn't believe Mr. Scott should be carried on from this point on. There is much upheaval by his promotion and pushing the drag queen story hour that is damaging to our community. The library needs a person that can handle the upheaval and bring back calmness to the situation and Mr. Scott is not the person.

Janice Jones stated that the Board is doing a great job compared to the past. She is looking forward to some bylaw changes that Vice Chair Jack mentioned last month. Now I would like to comment on the evaluations because on the 18th of December there was one evaluation where five out of five Board members responded and the very next day was a different evaluation where only four out of the five Board members responded and the numbers changed, but either way both evaluations clearly shows that your standards are not being met. Recommended that the Board seriously consider creating bylaw that compels the Director to submit on a quarterly basis all proposed library programs complete with design details and estimated costs for the review and approval of the Board.

Janet Butcher stated that on June 17th of this year she went to the North Valleys Library since she had heard of a special event so she believed the library would be open to the public. She stated that she recognized Director Scott and approached him to inquire as to why the library did not feature story hours having to do with founding or our nation the constitution Fourth of July and a potential educational events. Someone approached and began to blow bubbles directly into her face. When I asked them to stop Director Scott began to mock me and encouraging them to continue. Director Scott told me that if the bubbles were bothersome I should put a mask on and step back. He never suggested to the person interrupting the conversation to stop. Then others came behind me and began to deliberately blow bubbles at my back. I found his actions unworthy of a person in his role. She took the issue to HR and HR told her that Mr. Scott violated no policies and so there is no policy in the County against allowing promotion of harassment against the patron.

Stacy McKenzie stated that she serves very proud and happily as the Assistant Library Director. She stated that she has only been with the Washoe County library for six months which is actually longer



that the Library Board and in that time I have gotten to know a lot about our Libraries. She is a former Library director with over 30 years of experience in a variety of libraries, mostly public. She stated that she wanted this job to work in a larger thriving library system that works to help all the members of its community especially those targeted and underserved. When I saw the comment about drag queen story time it let me know that I was going to be in a welcoming environment that was run well that was exciting and inclusive and that the library was doing what it should be doing. Mr. Scott is a fantastic library director to put it most simply. She feels that he is well aware of what is going on in the industry, in local government, and at the various branches. Staff speaks highly of Director Scott and the support they receive from him.

Victoria Meyer stated that she sent the Board the video where Director Scott is commanding the patron to step back and laughing. She believes that he has been very disrespectful at events and a month ago you were in receipt of other videos showing patrons at events where somebody got shoved and police were involved with reports being made. She mentioned reviews for Director Scott from 2018 and reports of the deceitfulness he showed in Berkley. Brought up the Washoe County report from 2018 where staff resigned at the meeting. The report showed that Director Scott showed deficiencies in his internal communication skills and extreme lack of leadership ability creating hostile and toxic work environment from beginning.

Jeffery Meyer stated that he concurs with the previous speaker. Feel that Director Scott is a problem and "needs to go." We don't need him running our libraires. States that Director Scott has been extremely rude to him. Stated that he doesn't understand why I would need a minor kid to enter the drag queen story hour event.

Stacy Spain stated that she is the Executive Director of the Our Center but speaking as an individual. States that she has seen nothing but a staff that absolutely supports their director. Staff works very hard for the Director of the libraries. Director Scott is a man with so much patience. Believes that Director Scott is someone with patience and someone who behaves professionally, someone who receives so much vitriol from folks. Believes that he runs a great organization whose staff supports him.

Sandy Tibbet read a quote attributed to Director Scott. Stated that Director Scott's response to a scandal of reading books from a library in Berkley California was callous. Stated that there is another article that indicates he initially lied about the number of books he sent to be mulched originally it was 2200 and he later acknowledged it was 39,000. Stated that she and others attempted to go to the Saturday June 17th drag queen story hour at North Valleys library, but were told by Jeff Scott we cannot enter because the public library was closed to the public on Saturday and they had only opened it for the special event. This was another lie as I know the North Valleys library is open every Saturday. Feels that Jeff Scott is pushing a troubling agenda that involves a narrative of labeling his community members of being book bannered through the use of the social media accounts.



Aspen Morerro stated that she is very excited that our libraries offer drag queen story hour. Feels that the events should be limited to those with children. Stated that she is appreciative that Director Scott has vouched for the LGBTQ community. In regards to the complaints I heard they seem to be complaints from about five years ago or longer and they seem sematic in nature and to me it seems like these were people whom were used to getting their way are the complainants about now having to make more room at the table.

Sarah Cados stated that she feels that the library has headed in an extremely positive direction and all of her family's experiences with the library programs of the past several years and the volunteer program have been very positive. Stated that volunteer bias is when a decision is based on a sample of people who volunteer themselves to show up because that is going to be a bias sample that doesn't represent your entire population.

Jaime Hemingway stated that she is the Public Information and Development Officer for Washoe County Library. She supports Library Director Jeff Scott. States that Director Scott has given her freedom to launch the Explorer publication. She has worked with Director Scott to submit grants for book kiosks, virtual meeting rooms, and for the new book mobile that is up and coming. He has helped me achieve my career goals and provided support along the way. If you look at the annual report for 2023 you will see we have had some successes under his direction this year. Population served over 500,000 of course of that population we have had 239,000 folks walking into the door checking out items. That's the number of patrons we have waling in. 2.4 million number of checkouts and number of computer users are 85549. She is grateful for the drag queen story event has attended and it matters to people like her and others.

William Puchert stated he has been appalled by the abuse that Mr. Scott has gone through by certain members of the community who also do this at various other government meetings. Respectfully reminded Board that the job of this board as a trustee is to safeguard the library's mission and not to pander those who wish to harm the library with their bullying antics instead of defending it. In a sense the struggle is like fighting the board attempting to assimilate our libraries with their narrow minded negative and homophobic agenda as they seem to take control and remove programs and books.

Maureen McElvoy stated that she strongly supports the efforts and work of Director Scott and adhering to the Washoe County Library mission of connecting people with information ideas and experiences to support an enriched and engaged community and the American Library Association bill of rights which supports a diverse library collection freedom to read and the freedom to view at a time when there are so many ideas and opinions on related distresses.

Allen Munson stated that he appreciates the long hours put in for the meeting. Views leadership as being able to solve problems and bring people together when there is diversion. Jeff Scott had done nothing to resolve the division. We need new leadership that would work with the community.



Debbie Stears stated that she is the Collection Development Manager based on trustee comment wanting to hear from staff. Director Scott has invited the community to public meetings, conducted surveys, and work with staff to come up with a cohesive plan to make it transparent and has built everything that we do to funnel into that plan so that we have a contract with the community about what it is we are trying to establish. Further states that under Director Scott's leadership we see a current strategic plan called to expand the services to seniors you will see we have homebound delivery services he secured a grant for a book mobile with focus on book deserts. We have three book kiosks in the underserved communities and that bookmobile will also serve the underserved communities. He brought high speed internet to Gerlock. Our community has benefited from his partnership.

Roger Edwards states that he worked for the County eight years in the planning commission and four years on the Regional planning commission and is a military veteran. Elected officials have to remember that the view of what the community has of the library board is critical. You cannot keep having someone that constantly keeps the library in the news for the wrong reasons. There are a ton of people out there that can do the job mostly library managers can do the job without any management at all. So the period of time it will take you to find a new director shouldn't dissuade you from making the right decision. The community is concerned about some of the policies and the programs that director Scott brings forward are more for his personal interest and not what is best for the library--What is best for Washoe County should be the bottom line of consideration.

Reva Crump stated that the Board has been provided with the May 2018 meeting public comment section and questioned why the director not receiving annual reviews because this is an obvious deficiency. The last review in 2021 of which was not included in the agenda package and as such what bias did the board have that they did not receive that package for comparing his performance from previous to present. The board is starting from scratch due to not knowing the information. The may2018 board of trustee meeting clearly reflect that its not the first time this board has had a problem with Director Scott. We must acknowledge that May 2018 is out of scope of the evaluation of the current board the significance is that the time frame is literally only three working years ago as the libraries were mandated during the years of 2020 and 2021. He received a glowing evaluation in 2021--your library wasn't open part of that time. Hopefully this board will fix the issues.

Bruce Parks stated that Director Scott did not receive an evaluation in 2022. The previous board has abdicated their responsibilities and their duties to make sure problems are addressed that hasn't occurred. Stated that he hopes this board will do their duty. Feels Mr. Scott is a bully, stating that he has seen his demonstrative performance at certain events. He does not intervene on behalf of patrons at the library when they are being harassed by other patrons on the contrary he supports the harassers. Question need asked is if it is worth keeping this individual on Washoe County payroll in light of what may be coming, such as pending lawsuits from abusing his power. Simple questions have been asked by board members regarding finances and no answers are given. My simple question that I have been asking is what is the cost for the drag queen story hour and for months have gotten no answer. I am saddened that the board has not addressed the behavior of this directive.



Richard Dalton urged the Board not to listen to the public comments but to the County employees people who work in the libraries. You listen to other employees talk about how wonderful the library director is and the wonderful job he has done that is what you should be paying attention to is what the library employees have to say about the director. Look at the work he has done.

Scott Meyer stated he would just like to see things straightened out and wanted to know why people are being banned.

Scott Finley stated that Director Scott has failed in his duties and responsibilities as the library director. The Board of trustees must evaluate Jeff Scott based on his merit which is lacking. Stated that homeless individuals go to the downtown library, view pornography and masturbating. Children at the library can observe this behavior and Director Scott has taken no action to stop this.

Val White stated that Director Scott has police reports filed against him and physically handled a patron at a library. He has also received complaints from employees for his terrible actions in his reign of terror he has a few years to literally clean house. The fact that plenty of library employees showing up to defend Director Scott is not surprising because Director Scott has cleaned house of all others. Asked why Washoe County would hire such a loser and employee who is very likely to sued for his actions and leadership.

Marie Rodriguez stated that she thinks about the library in terms of her grandchildren going there. Stated that she was surprised at how much growth there has been in the public libraries, how many events and programs are available that were not there years ago. She learned about the Steam program for science and technology arts and math and the ongoing summer reading program as well. She learned about the knitting and crocheting that is being taught to young people and the quilt making event as well. The express computer available to people who do not have access to a computers in the home and the legal resources available this is what I think about when I think about the Washoe County libraries it is a place for resources a place for community.

Julie Ullman stated that she worked for the Washoe County library system for over 20 years. Believes that the 360 review would be good. In March 2020 all of the Washoe County public libraries closed due to the Covid19 epedemic there was uncertainty if staff would be laid off or worse. Director Scott's leadership and with plenty of staff input protocols were put in place to allow library staff to work in the building part time using split staffing so no cross contamination would cause more shut downs. Library staff worked to create and record virtual story times for our community. Also created Steam activity shared through the library's website services such as digital library cards and E newsletters. With Jeffs leadership and insight the library worked out plans to begin limited services at the branches. On June 16th 2020 we started the drive up windows with grab and go. During the shut down staff still regulary received library director updates through staff emails and staff and public safety were always the first and foremost in these communications. Today the South Valleys library is busier than ever surpassing pre-co stats on the



checkouts and library visits. The library system has thrived under Director Scott's direction and the future is brighter than ever.

Presentation by Assistant County Manager Dave Solaro and Board Discussion:

Dave Solaro, Assistant County Manager, presented a slide and walked the board through the Evaluation of the Library director for 2023. The materials provided are the subject of this item is the recommendation performance evaluation for Jeff Scott including a discussion of the results of the 2023 performance feedback survey and the adoption of priorities and expectations for the library. There have been some comments related to the materials that was provided to this board and I want to clarify a couple of things that did occur during the process. Washoe County Human Resources created a survey for this board to take for the director at the direction of the board in 2021 the guestions were created by the board in 2021 and provided to the five library board directors this is a completely anonymous survey, so we do not know who takes the survey. During the process four trustees took the survey and the results came in. One trustee called me to say they were uncertain about the survey process, so I walked the trustee through the process, and we received the fifth survey. The package was already prepared with only four surveys in the package, so we had to redo the package to show the fifth respondent survey. This is why there is a second packet of information for the trustees. Wanted to make sure this is on the record nothing nefarious to figure out how to make sure this does not happen again in the future. Trustees you have been provided with information from myself you have taken the survey and I have provided all the information from the four trustees that took the survey. The comments that were made have also been provided in the packet. They have been provided to the community. I have also individually to you all provided you with some information that I got directly from the Washington Human Resources its important that the information com from the County Human resources because the staff of the library system are actually Washoe Count staff members your staff member is director Jeff Scott you do not have essential survey over the staff members here in the library they fall under Human Resources so I provided you any complaints from the director reports about the director there were zero. I prepared you then any grievances filed against the director and there were zero also complaints that were filed in the library system I provided you that information so you have that available for you when you took the survey you also heard from director Scott in October of the work that he has done over the past couple of years for the library system and all of that information is the information that you need to take into account as giving the direction to the director on those expectations and where you would like to see the library system go next year. I do have a short little presentation here related to this item. Under Nevada revise statutes you the trustees of the library your job is to evaluate the performance of and if necessary to sub library we are here to do the performance evaluation also, under NRS I have provided direction or provide notice to director Scott that he would be talked about in this public hearing about his evaluation. In November of 2021 the library board of trustees gave me direction on how to create the survey, who was to take the survey, and what the process was to go through that is the process you went through this evening. On October 26th the surveys were distributed to you all on November 22nd survey closed held that open through November 30th. Which caused some of the confusion I spoke about earlier. On December 1st I provided director Scott



in person with a letter signed by myself and chair Perez notifying him of this meeting tonight. The survey as directed by the Board of Trustees talks about leadership, integrity, and communication the board support management and then there was a piece added in by trustee Perez as a matter of fact to talk about the Strategic plan. The director has been performing against the Strategic Plan so that is the information that was in the survey questions it also requests that you provide an overall evaluation for the director. The responses could have been exceeding expectations, meets expectations, an area for growth where the evaluation has no basis for judgement. I think it is very important to point out the reason there was not an evaluation last year was because we did not have a full board for much of the year 2021. In fact, this board was just most recently fully seated in October of 2023. We have a very young board with the director to take this survey, that is why we have the categories. The response rate was 80% with four of the five trustees taking the survey.

We have a point of clarification. One trustee asked Mr. Solaro if she misunderstood but she thought he indicated that we went back in fact within the fifth trustee evaluation. Dave Solaro responded no we actually went back and took out the duplicate items we had five but one person has taken this twice. As mentioned in the staff report with the young board like this as you may expect there are some areas of growth with the director I believe there is opportunity here with this board to give good clear guidance to director Scott on any of these items that you feel. As the survey came out you will see in the notes that not every survey question has four comments with it I have four trustees that took the survey not all four provided comments for the director so this is the opportunity to provide any direction to director Scott if you were one of the people that did areas of growth or even meets or exceeds expectations. This slide shows information related to how the trustees are feeling about director Scott and half the trustees are looking for areas of growth. That area of growth is really what we need out of this evaluation to provide to director Scott so he can perform what you would like him to be performing. Trustee Leah asked for clarification is there a reason that the meets expectation and exceeds expectation are grouped together as they are two separate questions in the survey. Dave Solaro responded they are two separate questions in the survey responses and I am just going by the way the Human Resources Department does other evaluations for members done in a public hearing so meets or exceeds expectation is the benchmark that they utilize so they are combined that is the way Human Resources did this presentation it shows that the trustees that took the survey feel Jeff meets or exceeds the expectations for them. Another trustee asked if there is a difference between meets and exceeds the expectations. Dave Solaro responded that yes there is a difference between meets and exceeds the expectations in this instance really the bar we are looking at is meets expectations. That is the reason of the combination from Human Resources the bar essentially for many employees of the County geta a needs or exceeds expectations you are meeting the requirements for your job position. Jeff Scott followed and worked towards meeting the strategic plan one of the trustees had no basis for this question one said this was an area for growth.

Ann Silver was not happy with the evaluation or the process she felt she was not doing her obligations by coming in on the tail end of the evaluation she was not satisfied with the trustees not having comments on the comment section and that not all five trustees had taken the survey. She questioned the very content of the evaluation not accustomed to rate someone I have barely worked with or know. I am not



accustomed to someone not participate and someone have no comment. I would request this be postponed so that some of us can have more time in which to take ownership of this evaluation. We owe the community and ourselves that.

Mr. Solaro responded that was his struggle is to figure out how to take the direction of the board that was given in 2021 and create that process that is meaningful to the board and the director. However, I would suggest that you have information available to you today along with your hours of public comment to be able to provide priorities and expectations of the library. I would suggest that is the most important part of this process. You heard from Mr. Scott in October about the things the library has done the accomplishments are all based on the evaluation that was done in 2021 and the things accomplished through that period of time. Really take this information because that is all is information this is not necessarily the full evaluation of the director. I recommend the direction from this board on your priorities for the director. The expectations you have of the director in the library system are really the important part to be able to evaluate. Postponing this item does not give Jeff any additional information on how to perform for this board. I think we can do another evaluation at another point in time before a year is up but I think you have to give the director some direction on what you all want or expect as the Board of Trustees.

Trustee Silver reiterated her objection to moving forward on the evaluation at such a late hour. The public and Director Scott deserves a thorough discussion on the evaluation. Doesn't feel emotionally or physically equipped to continue after 5 hours of meeting.

Trustee Moser was also not comfortable moving forward with the evaluation and motioned to have the evaluation moved to the next meeting. No metrics for goals and accomplishments. Want to work with county to come up with a better evaluation process.

Trustee Rogers feels comfortable with moving forward with the evaluation. Evaluation process starts on first day as trustee. Provided feedback on the survey provided.

Trustee Moser stated that Director Scott did not provide his own self-evaluation.

Trustee Rogers continued to state that the Board is tasked with acknowledging the evaluation and feedback provided. Encourages the trustees to meet with Director Scott to discuss moving further. The Board has pushed many things down the road. Believes that the evaluation should proceed.

Chair Perez agrees that the process should go forward. He provided feedback to Director Scott and responses to the survey. Looks for a motion to provide feedback to Director Scott.

Trustee Jacks moves that the Board accept the information provided contingent on having a closed executive session with Director Scott pursuant to Bylaws. Discuss the future of Director Scott in private for his and the Board's protection and privacy. Disciplinary actions can be conducted in private.



Trustee Moser states that she confirmed with the Attorney General's Office that the Board could not conduct a closed personnel session. Again urged to table the item. Does not feel comfortable moving forward. She moved to table the item.

Trustee Silver states that Trustee Jacks is asking for something not at the Board's disposal. Does not have information enough to provide a meaningful evaluation. Would like a thorough evaluation to respect the commenters and the process, as well as Director Scott. She completed her responses to the survey as best as she could. The Board has the obligation to conduct the evaluation, but does not feel that there is enough information and at that late an hour. Seconds Trustee Moser's motion to table item.

Yea Nay Silver Jacks Moser Rogers Perez

Motion fails.

Trustee Jacks moves to have Director Scott immediately voluntarily resign. Move to fire Director Scott immediately and move forward to find a new library director immediately.

No second to the motion. Motion fails.

Chair Perez moved to approve the library director's evaluation and possible direction to the library director. Trustee Rogers seconds the Motion.

Trustee Jacks states a possible amendment to the motion to allow discussion of future performance of the director to include possible termination of the director.

Amendment rejected by Chair Perez.

Bruce Parks, unrecognized by the Chair, states from the public that he will be filing a lawsuit.

DA Kaplan states that there is nothing on the agenda to suggest that termination of the director is possibly anticipated. The evaluation is at issue. As agendized, no basis for the Board other than to provide guidance to the Director as to how to move forward.

Trustee Jacks indicates that there is a reference in the staff report to possible dismissal of the director. Believes possible termination is within the Board's purview.

DA Kaplan indicates that as agendized, there is no basis to terminate the director.



Chair Perez provided feedback. Said incredible honor to work with Director Scott. Appreciates following the goals set out at the last evaluation. Follows the strategic plan. Has been to nearly all of the libraries in the system and the system is run efficiently. Feels that Director Scott should be more responsive to requests from trustees. Needs to have the ability to accept constructive feedback from the Board.

Director Scott assures that he will provide documents and information requested.

Trustee Rogers states that he has provided feedback already. Looks forward to moving forward and working with Director Scott to improve the evaluation process.

Trustee Silver states that as a leader of a large organization, and a public servant, that immediate resolution of the Drag Queen Story Hour. That program has never been discussed by the Board. Would like to see Director Scott to find ways to resolve conflicts without excluding or banning individuals. Would like a robust discussion with the Board about accomplishments and constructive criticism.

Trustee Jacks asked whether approval or not approving the motion, what happens if the evaluation is not approved.

Mr. Solaro states not sure he can answer that as there's a motion on the floor and discussion.

Trustee Rogers states that he believes that they are just acknowledging the information provided.

DA Kaplan feels there will be no motion passed at this time due to the trustee comments at this point. If that is acceptable to the board then you can move forward on that basis and they can re-agendize for further evaluation, further guidance and if the boards pleasure is to add the possibility of termination we can add that. But at this point we are at a standstill. I don't see any motion passing. Trustee Silver has made her position clear. Trustee Jacks has made her position clear. And Trustee Moser has made her position clear. So we have failed motion to table the item. We have failed motion to have Director Scott voluntarily resign. The board can accept the information that has been provided or the board can table it and we can do this all over again.

Chair Perez motion is the approval of the library director's annual performance evaluation for the period of 2023.

Trustee Silver makes a point of clarification, if she understands, approving the evaluation is merely accepting the information that has been provided.

Dave Solaro confirms that and that he has taken notes on moving forward to change the evaluation process.



Trustee Moser feels they are unable to fully assess Mr. Scott with the evaluation and is unsure if approval of this evaluation means that the ambiguous comments that were made are the direction that the board will go for the next year I cannot in good faith feel confident in supporting this motion without further detail regarding the evaluation and will vote nay to this motion.

Chair Perez asked for the vote all in favor of the approval of the library directors annual performance evaluation for the period of 2023 please signal by saying I any opposed please signal by saying nay.

Trustee Jacks suggests another motion be allowed rather than table.

Trustee Silver moved to accept the data and discuss feedback and direction to Director Scott at a future meeting. Trustee Moser clarifies what she understands. Chair Perez Seconds.

0) For Possible Action: Select an Option for Meeting the Materials-Expenditure Standard Pursuant to the Minimum Public Library Standards as Set Forth by the Nevada State Library, Archives and Public Records

Debbi Stears Collection Development Manager the State mandates this report be turned in the library board has one responsible action item for this and that is selecting a funding formula for what we spend on the collection. There was a whole list of standards that was included in the board packet. It includes things like the written master plan that we have policies that we publish our hours etc. that's been provided. Option one is that we meet or exceed at 90% the five year average of the previous five years. Option two is a formula that we meet or exceed a 30% the total services and supplies budget. The third option is we hit the standard of 10% of the total operating budget. We talked about the expansion fund and wanted to point out this hits the collection tremendously the board of County Commission out of our \$1.4 million dollars the Board of County Commission only allocates \$54,000 to fund our materials. The \$1.36 million comes out of the expansion fund. Option one shows the historical data of the five years if we want to select this as a minimum funding standard let me say that \$1.41 million selected its budgeted that is what we are spending to check off to the stated we have met the minimum standard.



This is the lowest standard that would be at \$880,000 supply. Option two is the mathematical formula which has us going into 30% we are actually at 44.9% so that minimum standard would be \$944,000 we meet that standard and the 10% standard we do not meet it would require a \$1.6 million which we have not been able to meet. Do want to show the way the budget has grown over recent years from \$646,000 from nine years ago to the \$1.4 million we are at. 8.8% we are close really hope to get to 10% next year. The three options before you out that 1.14 million. Option one and option two are the only two we can meet you as the board get to select those two options. I would encourage option two because that's aggressive that we have the funding to meet but the decision is up to you and I entertain a motion.

Trustee Rogers made a motion to approve the staff recommendation and select option two.

Trustee Moser had a few questions regarding the suggestions is to choose a different standard that we can meet so I am concerned about what is going on that we can't meet the current standard and haven't been able to in nearly 10 years if we don't have the collection, we should to support our population just curious what metrics we are using all along that would make ourselves more compliant. What is the impediment to reaching that goal? There is not enough information from what I can see from the board deck to understand why we are unable to reach this goal. I don't think it's the right action to change the goal just because the director is not able to meet this goal so I would appreciate discussion on this topic. Debbie responded what the State requires is that the library board meet a minimum standard for funding the collection it lays out three different options it has a fourth non desirable option which is we cant meet this and her is our plan even the most basic minimum standard and her is our plan to getting into compliance. Fortunately, we haven't been in that situation. We are primarily funded by the County the secondary expansion fund that is soon to sunset the County during the recession years cut the library budget dramatically and has never restored any of that funding towards materials all of that expansion that we have seen from the \$600,000 when I came to the \$1.4 million 100% of that growth has come out of the expansion fund the County does not put another penny in the nine years I have been her. I made the ask and presented in the County Commission meeting pointing out that we were not meeting the industry standard that we have a previous library board that set that as a goal but that is up to the board of County Commission to approve the County budget and to make that funding available. Trustee Perez asked if this is the reason we cannot meet the goad is because the budget that is given by the County answer was exactly.

Valerie Fianacca cautions the Board that they need to be careful about what the library spends its money on. Can't rely on the continued revenue from the tax that is expiring. Drag Queen Story Hour is the only thing that most people complain about. Tax must be passed by the people.

Trustee Rogers motion to move to approve the staff recommendation and go with option two as stated in staff report. Second by Trustee Silver all voted I motion passes unanimously.

Board advances renewal of library tax override to appear on General Election ballot: In 1994, Washoe County residents voted for a 30-year dedicated tax override of \$.02 for every \$100 of assessed property value for the Washoe County Library System. In September of 2000 the Board of County Commissioners, through a resolution, created the Library Expansion Fund for the purpose of clearly identifying the funds received from the tax. The funds must be used for the expansion of services including, but not limited to, additional library branch debt service payments, expanded library services, expanded library hours and additional library collections.

The tax override will expire at the end of this year unless renewed by voters in the General Election in November, and for the question to appear on the ballot, the Board of County Commissioners must first approve the resolution.

"This is the approval of a resolution that allows a submittal of a question to all registered voters," Deputy District Attorney Mary Kandaras clarified. "Essentially you're approving the resolution, which is in your power, to put it on the ballot. In the General Election, voters would decide if they want the tax."

BCC Trustee Rogers reappointment and Tax Initiative (poll results) (Bookmobile at County Conference)

Our Renew Washoe County Libraries Tax Initiative was approved to be placed on the November ballot. This is a big win for the library and will allow us to enter Phase III of our renewal plan.

Trustee Rogers was not reappointed at today's meeting. The Commissioners wanted to open a new recruitment. However, Trustee Rogers will be able to apply during this time and will remain on the board until he is reappointed or a new trustee is appointed. The timeline for new recruitment and appointment will likely take us through August of this year.

Renew Washoe County Libraries Initiative Update

On November 5th, 2024 Washoe County voters will decide whether to extend a 30-year tax dedicated to acquiring, constructing, improving, maintaining and operating Washoe County Library System. This is a renewal of a 30-year tax, not a new tax. An allotment of 2 cents for every \$100 of assessed property value goes directly to Washoe Libraries. This is not an additional tax on Washoe County citizens. Our goal is to maintain the award-winning outstanding library service Washoe County residents have come to enjoy.

Washoe County Board of County Commissioners approved the library tax override for the November Ballot. We are now entering phase III of our plan.

Phase III will be the home stretch of the tax renewal plan.

Media Blitz/Library Campaign with library staff. Get on the radio, get on TV, get on the news about the great services we provide. Discuss Library Tax to local TV Radio, newspapers, and other outlets. Increase presentations to rotary clubs, neighborhood groups, advisory boards, and more.

Community Partners promote the library, library supporters pay for advertisements.

Countdown to November 5th vote, develop a plan to vote, continue to get library spotlights on local media.

We currently have paid social media posts and voter education ads running on This is Reno and PBS Reno. Local artist Grace Hayes also created two wonderful videos for us, talking about all the great things available at the library and the need to protect the freedom to read.

Our political consultant Riley Sutton recently conducted a poll, revealing that if the vote were to be held today, we would secure 68% of the vote. I will provide an executive summary of this poll at the July meeting as it gives us direction on how to talk about the tax override and what we should focus on. This is a direct result of the good work our library staff do and voter education efforts, which are focused on explaining the benefits of the tax override. We are highlighting the extended weekend hours, the recent renovations, and the future renovation plans for South Valleys, Spanish Springs, and Incline Village Library.

We will have posters and brochures in our library to assist with our voter education efforts. The more we can educate the voters on what the tax does and that it does not raise nor lower taxes it merely instructs Washoe County to give a portion of taxes collected directly to the library the more support we will gain.
