Forum Restrictions and Orderly Conduct of Business. The Library Board of Trustees conducts the business of the Washoe County Library system and its citizens during its meetings. The orderly, efficient conduct of the meeting is integral and necessary to allow the Board to conduct business. The Chair or presiding officer may order the removal of any person whose statements or other conduct disrupts the orderly, efficient or safe conduct of the meeting. Warnings against disruptive comments or behavior may or may not be given prior to removal. Examples of disruptive conduct include, without limitation, yelling, stamping of feet, whistles, applause, heckling, name calling, use of profanity, threatening use of physical force, or any other acts intended to impede the meeting or infringe on the rights of the Library Board of Trustees, staff, or meeting participants. The viewpoint of a speaker will not be restricted, but reasonable restrictions may be imposed upon the time, place, and manner of speech. Irrelevant and unduly repetitious statements and personal attacks which antagonize or incite others are examples of speech that may be reasonably limited.

<u>Public Comment.</u> Public comments are welcomed during the Public Comment period at the beginning and end of the meeting for all matters, whether listed on the agenda or not. Public Comment is limited to two (2) minutes per person. Persons may not allocate unused time to other speakers. During the "Public Comment" items, anyone may speak pertaining to any matter either on or off the agenda. Anyone wishing to provide live public comment may do so in person, or by teleconference by logging onto the Zoom webinar by accessing the above link. To provide public comment via Zoom, log into the meeting at the above link and utilize the "Raise Hand" feature during any public comment period. Additionally, persons are invited to submit comments in writing by emailing Jamie Hemingway at JHemingway@washoecounty.gov The County will make reasonable efforts to send all email comments received by 4:00 p.m. on the business day before the meeting to the Trustees prior to the meeting.

<u>Response to Public Comment.</u> The Board can deliberate or take action only if a matter has been listed on an agenda properly posted prior to the meeting. During the public comment periods, speakers may address matters listed or not listed on the published agenda. The Open Meeting Law does not expressly



prohibit responses to public comments by the Board. However, responses from the Board members to unlisted public comment topics could become deliberation on a matter without notice to the public. To ensure the public has notice of all matters the Board will consider, Board members may choose not to respond to public comments, except to correct factual inaccuracies, ask for Staff action, or to ask that a matter be listed on a future agenda. The Board may do this either during the public comment item or during the following item: "Board Comment – limited to announcements, strategic plan activity updates, or issues proposed for future agendas and/or workshops."

- 0) Salute to the Flag
- 1) Roll Call [Non-Action Item] Chair Silver present, Trustee Moser present (left meeting at 6:04 pm), Trustee Jacks present, Trustee Rogers present (via zoom).
- 2) Public Comment –Three-minute Time Limit Per Person [Non-Action Item]
 - 1. John Wilson Spoke in favor of LGBTQ materials and programs at the library as a valuable resource for parents, teachers and all members of the community.
 - Bruce Foster Described and presented books for suggested donation to the library then
 read from a library book from the collection (was asked not to continue the recitation).
 Ended comments with, "We have a bunch of perverts on this board."
 - 3. Nathan Brown Stated that he is speaking in support of the LGBT community and will not return due to not feeling safe from the anti-LGBTQ comments.
 - 4. Joni Hammond Spoke against the DSH stating she was working toward protecting children.
 - 5. Cliff Nellis Spoke against the LGBTQ community as being contrary to nature and, the crime of sodomy as anti-social. He spoke against Director Scott's leadership of the library.
 - 6. Naseen Jamnia Spoke on support of library staff and their programming, specifying that the board should fully support voting in favor of library funding.
 - 7. Geoff Knell Read from the bible and said that LGBTQ is political and spoke in opposition of DSH. Stated that the library was breaking the law by hosting these programs. He ended comments complaining about being banned from the library for breaking library policy and "because Director Jeff Scott is a sexual deviant." Called for him to be fired and said, "Jeff

- Scott, keep an eye on me because I am coming for you." He was advised by Chair Silver about making threats.
- 8. Val White Stated that Director Scott should be removed from his position permanently. She discussed his presence and discussion with Director Scott at a coffee event hosted by Trustee Jacks. She listed her issues with Director Scott.
- 9. Janet Butcher Complimented Trustee Jacks on her inviting the public to speak to her directly and stated her hand was up at the last meeting [via Zoom] and was ignored during the chair elections. She spoke against "sexual books" in the library collection.
- 10. Sandee Tibbett Read NRS about libraries being free and accessible and in opposition to her suspension and displeasure to response time. Spoke about interactions at DSH.
- 11. Candace Powell Spoke in support of "our" libraries. She expressed her support of the renewal of the tax override. She expressed alarm for the actions of the last library meeting.
- 12. Fred Meyer Spoke about Miss Tibbett's suspension. He spoke about the interaction and suspension during NV program. Asked for resolution at this meeting for the suspension, "Todav."
- 13. Victoria Meyer Asked for remarks in verbatim. Chair Silver explained that she needed to submit them in writing. Spoke on separation of church and state. Spoke against DSH and interactions at that event.
- 14. Reva Crump [Via Zoom] Stated that the meeting was in violation of open meeting law. Stated that there was a bylaw violation related to Trustee Rogers attending virtually. Complained about acoustics.
- 15. Bruce Parks [Navada Patriot via Zoom] Stated that his observations were that hate was not coming from the "right." Called for conversations and compromise from both sides.
- 16. Kelsey Penrose [Via Zoom] expressed the difficulty of hearing speakers.

Tibbits was argumentive in the storytime with staff and security concerning her sign. She would not identify who her child was when asked, including tell us it is none of our business violating the safety protocol that we had in place for this event. She also lied about being with the children that she brought to the event Switching between saying that one of the young girls was her grand daughter and then at another point identifying the young boy as her grand son when the girls left the event she did not leave with them at that time which is also a violation of the directives given at the event.

After the storytime, Tibbits was confrontations and not taking directives to back up, keep from yelling and being in the space of several staff. She was falsely accusing staff of detaining her children and made a false claim that the fire exits were not in compliance.

To: Sandee Tibbett,

After a thorough investigation of your actions and interactions with library staff on June 15th at the North Valley's libraries, your appeal for your 365-day suspension is denied. The suspension is lifted on July 20th, 2025, which is 365 days from your notice of suspension.

After staff and patron interviews conducted about your actions at this event, you were found to be in violation of the following library policies NOTE (any additional issues listed have been added to the original report of suspension as supporting evidence to deny the appeal):

Washoe County Library Conduct Policy-

1. Library users must comply with all applicable laws, codes and policies.

Library staff and security staff had to ask you several times to clear an aisle area.

2. Conduct that disturbs library users or that hinders people from using the library or library materials is prohibited.

You were witnessed by both staff and patrons to have your signs overhead and pushed toward other patrons during a dance portion of the Storytime and were argumentative with security staff when they asked you to comply with rules about controlling the signage and keep it from blocking other patron's view.

After the Storytime, you were confrontational, loud, disrespectful of staff's personal space as you were disruptive and yelling at staff accusing them of detaining your children when in fact you were not attending your children according to policy.

3. Behavior that interferes with staff's ability to do their job is prohibited.

Library and security staff had to ask several times for compliance on the above and issues.

Staff who witnessed you return to engage with library staff after the event concerning fire codes and your inability to remain with your children, took staff away from other duties to deal with the false claims.

4. Library users will not engage in behavior that could compromise the safety of themselves or others.

Security and Library staff had to ask you to several times to clear the aisle, you also refused to identify the child that you were with at the event, replying several times "that is none of your business," until you finally identified one of the children as your grandchild.

Washoe County Posting, Exhibit and Display Policy-

In accordance with Washoe County Code 80.520 governing solicitation on County property.

The signage that you displayed carried the logo of an organization which violated the county code that requires prior approval of such solicitation and display.

Washoe County Unattended Children Policy-

Children under ten (10) must be supervised by a caregiver at least thirteen (13) years old who is able to attend to the child's safety and ensure appropriate behavior.

You would not identify which child(ren) were with you at the event to verify that the child was attended stating, "It is none of your business."

If a child under ten (10) is found to be unattended in the library, staff will attempt to find the child's parent/guardian. If the staff cannot locate a parent/guardian, law enforcement officials may be notified.

You have made public statements about you not knowing the whereabouts of your children at the events implying that you thought they left with another attendees grandfather, but also being unaware that they were in the bathroom for a certain amount of time and then saying that they were allowed to leave with an adult other than yourself.

In summary, your actions at this event illustrate an intent to disrupt a library events, to disrespect and distract library and security staff from doing their jobs (including maintaining a safe environment), demonstrate a disregard for multiple library policies (including the appeals process for this suspension) and could have potentially put staff and patrons in danger including your own unattended children.

On June 20th at the Downtown Reno Library event, when we were attempting to deliver your suspension paperwork, you were again disruptive and refused to discuss the issues in a calm manner creating a disturbance for staff and attending patrons.

I hope that you can take the time during your suspension to read our library policies and understand that we need compliance with these issues to maintain a safe environment.

If you have any questions or need clarifications on any of our library policies, I would be happy to discuss them with you so that when you return as a patron after your suspension, staff patrons and you can have a safe and enjoyable library experience.

In addition, I will share the information that your appeal will be on the agenda to be heard at the Library Board meeting on August 21st, 2024, at the Sierra View Library. That meeting begins at 5:30 pm.



Patron incident at North Valleys Library June 15, 2024

Rainbow fest was held at the North Valleys library on Saturday, June 15th. Notices were posted online and on the door that the building was closed for this event and patrons were redirected to the bookmobile for library services. Ribar was aware of this closure, though was arguing with various staff throughout the day, before and after this event, about his issue with the closure.

I was inside the North Valleys library monitoring the story time when a staff member who was monitoring the front door yelled for me saying "he has his foot blocking the door, he is trying to come in." I went to the front door to see that Drew Ribar had his foot in the door, not allowing staff to close the door and was pushing his way in saying that the library should not be closed and similarly yelling about taxpayer money, etc. I walked up to the door and told staff to go ahead and move back and I pushed the door open and yelled for him to get back and as I walked out the door, he did step back, and staff closed the door and locked it behind me. I asked him to move to a secluded area for us to talk about the incident, but he refused and said this is a public spot and we could talk right here. He argued about the library being closed and I attempted to explain and was looking for security to help when I was called back inside by a staff member saying that I was needed inside the building.

After attending to the issue inside, I came back out and Ribar continued to ask me about the closure to which I responded, "asked and answered, many times" and he then began asking me about my opinion on pornography for children to which I said I was done speaking with him and he should not ask other staff the same questions or that would be considered harassment and he would be asked to leave.

I stayed in the area without engagement with him and he left a short time after without engaging any other staff as far as I know.

I later found out that the staff member who was trying to keep him from entering the door was injured with a large bruise on her arm. After discussion with all staff involved it was decided that he should be suspended. This is an extension of the suspension for Ribar who was suspended from the last Rainbow Fest at Sparks library.

Dear Drew Ribar,

After a thorough investigation of your actions and interactions with library staff on June 15th at the North Valley's libraries, your appeal for your 365-day suspension is denied. The suspension is lifted on July 20th, 2025, which is 365 days from your notice of suspension.

After staff and patron interviews conducted about your actions at this event, you were found to be in violation of the following library policies NOTE (This notice and any additional issues listed have been added to the original report of suspension as supporting evidence to deny the appeal):

Washoe County Library Conduct Policy-

- 1. Library users must comply with all applicable laws, codes and policies.
- 2. Conduct that disturbs library users or that hinders people from using the library or library materials is prohibited.

Harassment of staff by asking the same questions over and over and then turning toward inappropriate and accusatory comments was disruptive and disturbing to staff and patrons.

3. Behavior that interferes with staff's ability to do their job is prohibited.

The time that staff took to deescalate your repeated harassing questioning and to explain numerous times that the library building was closed for a special event took us a way from our regular duties and disrupted patrons attending the event.

4. Library users will not engage in behavior that could compromise the safety of themselves or others.

Upon being told several times by numerous staff, including a notification on the library door about the closure, you attempted to force your way into the library building by placing your foot in the doorway and yelling at staff to let you in to the building. This resulted in a staff injury.

5. Damage, destruction or theft of Library property (including, but not limited to: materials, furniture or equipment) is prohibited.

Your behavior was dangerous and put library staff, resources and equipment in danger.

Adult Patron Use of Youth Areas Policy-

"The youth areas have limited resources, including the number of staff available for assisting patrons and computer access. As a consequence, Washoe County Library System reserves the right to restrict adult patron use of these resources.

Adult patrons who are not in compliance with this policy may be requested to leave the youth areas."

On this day the library was hosting a youth program that took place in the main library space and thus facilitated and allowed restricted use of adults who were not accompanied by a child to this event.

In summary, your actions at this event illustrate an intent to disrupt a library events, to disrespect and distract library and security staff from doing their jobs (including maintaining a safe environment), demonstrate a disregard for multiple library policies (including the appeals process for this suspension) which resulted in a staff injury.



Mr. Myer approached me at the entry point for the Rainbowfest. He was wearing a washed-out grey colored t-shirt, long denim blue jeans, a similarly colored grey ball cap; eyeglasses with a black wire frame; grey or white facial hair. He asked some questions about the event, and I answered. After a while he got involved in the "discussion" regarding trespass of a different man (see report NV2024-018). After a few minutes, he further engaged me with repetitious questions about the nature of the incident with other people (not library or event services). I refused to answer his questions pertaining to other people's business with the library.

About that time another man approached having walked over from the "free speech zone," that was set up by folks wishing to protest the event, this man had a long in length, plastic corrugated sign with handwritten messages on it. It was in the style of those for yards with

two wire prongs for mounting in a lawn or similar earth surface. He was wearing a black t-shirt with colorful slogans on the front. I informed this man that he may not enter the library event space with the sign. I asked him to return to the free speech zone with his sign.

As I engaged with this man Mr. Myer began interfering with that conversation. His tone was aggressive and unrelenting. I informed the man in grey that if he did not cease his interference with my ability to do my job, I would be asking him to leave for the day. He became more aggressive in his tone and flat out refused to leave by telling me he would not do so. I asked him to leave for the day for violation of library conduct policy (#3), he again verbally and physically refused to leave. I notified him he was trespassing, and that law enforcement had been called. Allied Security intervened to enforce the trespass. I awaited the arrival of law enforcement for both incidents (away from the area per security protocol). The man with the sign remained outside the event perimeter.

Mr. Myer is suspended from all Washoe County libraries for 365 days for violation of the library conduct policy and refusing to leave the property when notified of trespass.

Fred Meyer,

After a thorough investigation of your actions and interactions with library staff on June 15th at the North Valley's libraries, your appeal for your 365-day suspension is denied. The suspension is lifted on July 20th, 2025, which is 365 days from your notice of suspension.

After staff and patron interviews conducted about your actions at this event, you were found to be in violation of the following library policies NOTE (any additional issues listed have been added to the original report of suspension as supporting evidence to deny the appeal):

Washoe County Library Conduct Policy-

- 1. Library users must comply with all applicable laws, codes and policies.
- 2. Conduct that disturbs library users or that hinders people from using the library or library materials is prohibited.

When asked to stop interfering in conversations between library staff and other patrons, Meyer became aggressive and harassing in tone and when he was asked to leave because of the continued disruption to those around him including other patrons trying to participate in library resources and programs, he refused and continued the attack on staff while they were in the course of their other duties.

3. Behavior that interferes with staff's ability to do their job is prohibited.

Meyer was asking repetitive and inappropriate questions about other patron's activities in a harassing and distracting manner, even after staff told him repetitively that those questions would not be answered as they were not pertaining to his own business with the library. This harassment kept library staff from other duties including monitoring the safety of the event.

4. Library users will not engage in behavior that could compromise the safety of themselves or others.

Meyer continued to complain to staff about issues surrounding other patron business even after repeatedly being asked to stop and when told that he would be asked to leave if he continued. He continued to interrupt conversations between other patrons and staff and became progressively aggressive and unrelenting in interrupting and keeping staff from assessing safety issues in the area and keeping staff from their duties.

After repeated attempts to ask you to stop harassing and interfering with staff conducting duties, you were notified that you were trespassed and needed to leave the area, you refused, and PD was called. We were advised to issue a one-year suspension by PD.

In summary, your actions at this event illustrate an intent to disrupt a library event, to disrespect and distract library and security staff from doing their jobs. Your demands at board meetings for them to address the issue outside of following the correct process for the suspension appeal shows an ongoing disregard and lack of respect for library staff and board approved library policy.



Library Director Update for August 2024

Gold Ranch Fire/Northwest Reno Library Evacuation Center

I commend our Northwest Reno Library staff for their fast reaction to the Gold Ranch Fire. As the fire was developing on Sunday night, we were contacted by Washoe County to open an evacuation center at Northwest Reno Library. Red Cross, Allied Security, and Washoe County oversaw the evacuation center operations, with a number of people staying overnight and throughout the day as the situation developed. Most were seeking a cool place to sit, charge their devices, and get more information (which a library is a perfect place for that). The evacuation order has now been lifted, and the fire's forward progress has been stopped. Great job, team!

Workplace Violence/Drag Story Hour

I wanted to update you on recent events. On Tuesday, July 23, Chair Silver, Assistant County Manager Dave Solaro, and ADA Kaplan met to discuss board matters. An issue that came up was a report from the Workplace Violence Committee regarding events at the June Drag Story Hours. Due to escalating attacks by protestors, one of which resulted in a protestor pushing a library staff member and injuring them, the committee has recommended discontinuing the program to protect our staff.

As a result of this recommendation, I have canceled future Drag Story Hour Events. I spoke with Stacey Spain of Our Center about this decision. We are looking for ways to partner to ensure support for our LGBTQ community. Reno Housing Authority Kiosk and Ribbon Cutting

The Reno Housing Authority Kiosk will make client resources more accessible, including access to the RHA website/access to RHA's forms page, where users can fill out, print, and scan forms directly from the kiosk. Access to resources such as 211nevada where users can find other helpful resources within the community. Access to Rent Café portal: Depending on if the user is an applicant, resident, or landlord, the user can scan documents, apply to waitlists, update personal info, & make payments






