- 0) Salute to the Flag led by audience volunteer, Cate Salim.
- 1) Roll Call [Non-Action Item]
 - Present: Vice Chair Moser, Trustee Rodriguez, Trustee Jacks.
 - Trustee Ruf was absent. Chair Silver joined at 6pm.
- 2) Public Comment Three Minute Time Limit Per Person [Non-Action Item]
 - Heather Cook: Verdi elementary school librarian. Advocated for keeping the Verdi library open and shared the importance of the library for the Verdi community.
 - Toni Poloni: Emphasized the importance of board leadership and urged the board to support librarians. Highlighted the importance of homebound services.
 - Cate Salim: Expressed concerns over the absence of budget discussions and highlighted the need to fill vacant positions. Spoke against the possibility of closing partnerships and shared concerns that branches that rent space like Sierra View and North Valleys could be next.
 - Krysta Flanagan: Shared support for a robust library budget and emphasized the importance of library partnerships. Thanked Vice Chair Moser and Chair Silver.
 - Drew Ribar: Claimed to be on a political ban list and expressed frustration for being unable to attend pride. Questioned Washoe County officials and librarians for their alleged complacency.
 - Vice Chair Moser tried to redirect Ribar when he addressed the audience instead of the board. Ribar refused and VC Moser called for a 5 minute recess. Ribar continued to repeat his comments.
 - Sandee Tibbett: Questioned why branches had been closed without board approval. Cited NRS statutes. Urged the board to delay closures until they can hold a vote.
- 3) Board Comment [Non-Action Item] Limited to Announcements, Strategic Plan Activity, Updates or Issues Proposed for Future Agendas and/or Workshops
 - Trustee Jacks encouraged homeschool families to utilize the library. Shared her appreciation for her fellow Trustees and Vice Chair Moser.
 - Vice Chair Moser acknowledged public comment concerning Verdi. Expressed her surprise at branch closures and stated that these closures did not come before the board. Shared that she spoke with Chair Hill on the issue and the desire to staff libraries while the funding is available. Expressed interest in learning more about providing public transportation to and in Verdi.
- 4) Approval of Meeting Minutes
 - Approval of Minutes from the Library Board meeting on August 20, 2025 [For Possible Action].

 On motion by Trustee Rodriguez, seconded by Trustee Jacks, which motion duly carried on a 4-0 vote, the meeting minutes from August 20, 2025 were approved.

5) New Business

- Discussion between the Library Board of Trustees and the Office of the County Manager providing an overview of the information provided to Assistant County Manager Solaro by individual Trustees for operating locations, times, and days of the Library system for fiscal year 2027 (July 1, 2026 – June 30, 2027) and possible direction to the Office of the County Manager staff related to Budget needs for the Washoe County Library System. [For Possible Action]
 - Assistant County Manager David Solaro addressed branch closures and reiterated that these closures were based on low staffing levels and had been discussed at the August 20th meeting. He shared a map of library coverage and stated that although staffing issues have closed a couple of libraries, there are plenty of branches the public can utilize. He shared his understanding of the board's concerns and apologized for the inconvenience. Shared a graph showing Reno's population growth versus library staff numbers.
 - Solaro presented three operating hour models for Fiscal Year 2027:
 Options A, B, and C. Solaro emphasized that operational hours need to meet community needs in the area.
 - Chair Silver joined the meeting at 6pm and apologized for her lateness.
 Asked Solaro if the 8 hour work day included lunch. Solaro clarified the 8 hours did not include lunch.
 - Solaro shared in depth information for each option and shared the concerns related to each, such as the issue of late hours during Incline winter, and reduced availability of story time with later opening hours.
 - Chair Silver asked about the book vending machine. Solaro clarified that it
 is not self-check but a real vending machine that allows patrons to check
 out available books. Vending machines are located in Incline Village, Cold
 Springs, and Sun Valley.
 - Solaro explained that these options were all created by capturing the sentiment of the board via comments shared with him by trustees. He shared that with all three options Duncan/Traner, Gerlach, and Verdi are not considered full-service libraries. There may be discussions with the Washoe County School District about staffing some of these locations. Solaro clarified that the board's ideal operational hours can be pieces of each option presented.
 - Solaro asked that the board decide which schedule they recommend. He
 will work with staff to create a staffing model to be shared at the October
 1st meeting based on the board's approved option.


- Chair Silver asked about the expansion fund and the money left within it.
 Solaro clarified that there is about 3.5 million left in the budget but that those funds will be used by the end of FY26. He further explained his reluctance to fill library positions until a budget is decided, to prevent future layoffs of newly hired employees.
- Trustee Jacks asked if any of the information the board sent Solaro would be available for the public. Solaro replied that he is currently focused on operating hours and that the information trustees shared was more operational in nature and will be considered later.
- Trustee Rodriguez asked if the library hours will take affect prior to FY27.
 Solaro replied in the negative. Trustee Rodriguez asked for clarification regarding the closures. Solaro confirmed that the temporary closures were due to staffing and not the budget. Trustee Rodriguez asked if employees are allowed to work four, ten hour days. Solaro replied that they can.
- Chair Silver shared her support for Option A and the extension of hours to accommodate working people who wish to visit the library in the evening and on weekends.
- Vice Chair Moser questioned why library closures went without the board's approval. Solaro reiterated that he'd shared the possibility of closures due to low staffing at the August 20th meeting. He shared again his desire to wait to fill vacant positions until a budget is decided so as to avoid future layoffs. He apologized for not notifying the board or BCC about these closures. VC Moser asked that future closures be considered with an emergency meeting. Solaro replied that emergency meetings would require proper notice due to Open Meeting Law, and it would not be in the library's best interest to have to wait for emergency closure approval.
- Chair Silver stated that the expansion funds could be used over a period time and help to fund positions. Solaro reminded the board that the library's yearly budget is 18 million dollars, and that the 3 million in the expansion fund would be mostly used up for the book budget. He also clarified that the FY26 budget was built to use up the expansion funds by June 30th, 2026. The base library budget would revert back to 12 million, meaning additional funding would need to be secured to keep the same staffing levels.
- Chair Silver questioned the use of self-check. Solaro shared that selfcheck stations allow for efficiencies. Chair Silver suggested staff could be utilized in other areas if self-check is exclusively used. She questioned why she was directed to self-check when there are librarians on duty.
- Vice Chair Moser questioned why library branches were built if staffing was low. Asked if after-hours meeting rooms are free of charge. Solaro confirmed they are free and available by reservation. VC Moser asked if

- staff must be present. Solaro answered that not all locations have exterior access and staff are required to close the building in those locations. Shared which library branches have drive up windows (Spanish Springs, Northwest, South Valleys).
- Vice Chair Moser asked about partnership libraries. Solaro shared the new scenarios for Duncan/Traner and Verdi. Gerlach is already staffed for 2 hours a week as part of a contract with the Washoe County School District.
- Solaro clarified the changes in bookmobile hours as a possible solution to the reduction in partnerships.
- Vice Chair Moser asked about revenue generating possibilities. Solaro shared that these possibilities would take staff time and that all funds would go to the general fund and not be allocated to the library directly.
- Trustees discussed which options they preferred. Trustee Rodriguez suggested they look at the options and vote at a different date. Solaro shared that their choice isn't set in stone and that he'd hoped to have an approved budget at the October 15th meeting. Trustee Rodriguez asked if the option they choose can still be changed if they find there is a need. Solaro confirmed.
- Chair Silver emphasized to the public that the option they vote on is not set in stone and may still be changed.
- On motion by Vice Chair Moser, seconded by Chair Silver, which motion duly carried on a 4-0 vote, the board approved Option A with the caveat that further analysis would be made.
- Solaro shared that the library's collections budget needs to be allocated at 10% of the general library budget due to population growth. The last time it was at 10% was in 2007. Solaro shared that this target amount was decided based on input from Collections Development Manager Debi Stears. Vice Chair Moser shared her support for Stears' recommendation and Trustee Rodriguez shared her appreciation of a robust catalog.
- On motion by Vice Chair Moser, seconded by Chair Silver, which motion duly carried on a 4-0 vote, the collections budget was set at 10%.
- 6) Public Comment Three Minute Time Limit Per Person [Non-Action Item]
 - Heather Cook: Reiterated the importance of keeping the Verdi library open. Cited Verdi's growing population and unique partnership with the Nevada Department of Wildlife and the Washoe County School District. Recommended the library be open on Wednesday afternoons to coincide with the school's early release day.
 - Val Wade: Urged the board to use data provided by librarians, and emphasized the need for staff-led decisions.
 - Virginia Larmore: Thanked the board for a productive meeting, and Solaro for listening to public, board, and staff concerns. Emphasized the importance of respectful discourse.

- Drew Ribar: Reiterated his concerns about political bias and alleged blacklisting.
- Pete Bansen: Thanked board members for replying to his emailed public comment. Urged the board to consult library staff and emphasized the importance of their expertise when it comes to deciding operational hours.
- 7) Staff Announcements [Non-Action Item]
 - Trustee Moser suggested forming an advisory group with trustees and library staff for ongoing input. Trustees shared that they will speak with librarians about Option A and work as a team.
- 8) Adjournment
 - Chair Silver adjourned the meeting at 7:18pm.

Good evening,

The information presented to this board over the last 10 months has consistently been a budget reduction of *millions* of dollars. Tonight, you heard county staff report a loss of 33% of the budget in 9 months.

Take a moment to feel what a loss of a third of your income at home.

Please take a moment to consider the impacts these cuts have on our library system.

And then reconsider your phrasing. Rather than, "I didn't make time to review and thoroughly understand the information presenting the impacts of these funding changes," try using, "That wasn't a priority for me this week."

Because that's what you're communicating to our community.

Sandee Tibbett for the record:

I support the temporary closure of select Washoe County library locations for a few days each month to address staffing shortages, and I appreciate the local news informing our community about these changes. The chosen locations I feel are very reasonable selections. However, I strongly object to the library staff's unilateral decision to implement these closures without prior approval from the Library Board of Trustees, as required by NRS 379.025, which mandates board oversight of significant operational changes. The library staff's unauthorized decision to close these locations without a board vote reflects a decade of inadequate oversight, which undermines my trust in their judgment, leaving me uncertain whether these closures are based on sound reasoning or unchecked staff discretion.

The library staff's actions not only bypasses the Library Board of Trustees' authority under NRS 379.025 but also risks violating NRS 379.040, which ensures free public access to libraries under reasonable regulations. By failing to ratify these closures, the board risks breaching its duty to manage the library effectively, potentially leading to removal of trustees by the County Commissioners (NRS 379.020(5)) for neglect of fiduciary obligations. These closures could also invite lawsuits from patrons claiming restricted access or scrutiny from the Nevada State Library for failing minimum standards (NRS 379.003).

Furthermore, these actions may violate Nevada's Open Meeting Law, as operational changes like closures should be discussed and voted on in public board meetings with advance notice; bypassing this process invites civil penalties up to \$500 per violation (NRS 241.037), plus attorney fees, and potential Attorney General investigations. Our library system and county cannot afford the burden of additional lawsuits.

I also share Commissioner Clark's concerns and question why library staff would presume to speak for the county commissioners by announcing closures in a news conference without prior approval. Are their motives to needlessly stir community unrest?

I urge the board to delay the temporary closings and hold a public meeting to vote on these closures to ensure transparency and accountability to prevent legal and operational fallout.

Two Funds – General and Expansion Funds

- General Fund
- Budget approximately \$12.5 million annually
- Approximately 101 employees
- Savings is not retained for Library
 - Lapses into General Fund reserves
 - "Rainy Day Fund"

- Expansion Fund
- Budget approximately \$4.5 million annually
- Approximately 23 employees
- Savings is retained for Library
- Residual Balance
 - June 30, 2025 (tax expires)
 - Estimated to be \$3.5 million
 - Must be used for original intent
 - Separate from general fund
- Compliance monitored by external auditors and Department of Taxation



Additional Support - \$1.3 million (from the General Fund)

- What is it?
 - Funding needed to add to the residual balance
 - Maintain flat Library budget during FY2026
 - July 1, 2025-June 30, 2026
- Why is this a transition year?
 - LBOT to assess operational needs
 - Post WC-01
 - Determine ideal funding levels
 - Propose solution to Board of County Commissioners
 - September 30, 2025
- Permanent solution anticipated for FY2027
 - July 1, 2026 June 30, 2027




LBOT provided direction to proceed with Option A with the caveat that there is room for continued discussion and adjustment.

Questions from last meeting:

- Staff schedules include a minimum required 30-minute unpaid lunch period. These may be longer, but not shorter and all time is unpaid.
- Automated materials handlers and self check out stations have assisted
 patrons and staff as technology upgrades. These were installed as capital
 investments to account for reduced staff in the early 2010's. These still
 require some staff assistance.
- Capital construction of libraries were completed in 2005 (Spanish Springs, Incline) before staff reductions which occurred between 2009-2012.

Conclusions:

- For Option A
 - To provide "books only" approach with extended hours increases staffing.
 - To provide "full service" approach with extended hours increases staffing.
 - 8 additional supervisory positions and approx. 20 various other.
- Staff Option also increases staff need but shows efficiencies.
- It is possible to provide "full service" approach and slightly extend hours.
 There may be operational shifts in how services are provided across the system.
- Additional options could be reviewed for hours and locations.

Washoe County Library System. [For Possible Action]

SUMMARY

The Washoe County Board of Commissioners (BCC) has asked the Washoe County Library Board of Trustees (LBOT) to review operational strategies of the library system and provide a recommended fiscal year (FY) 27 (July 1, 2026 – June 30, 2027) operating budget.

This item is intended to be a discussion between the Office of the County Manager and the LBOT to review staffing models as well as input received from our library branch managers that outline the personnel costs associated with preferred operating locations, days, and hours for each of the 12 branch locations for a proposed budget to be presented to the Board of County Commissioners in October of 2025.

PREVIOUS ACTION

At the September 17, 2025 Board of Trustees meeting, the Trustees provided direction to the Office of the County Manager to begin creation of staffing models around a proposed schedule identified as Option A, with the direction to discuss impacts with Branch Mangers and provide the staff model for further discussion at a special meeting to be held October 1, 2025.

At the August 20, 2025 Board of Trustee meeting, the Trustees provided direction to the Office of the County Manager to hold a special meeting on October, 1, 2025 as well as

committed to provide information individually to the Assistant County Manager for compilation of options to the Trustees at the September 17, 2025 meeting.

Various budget discussions have occurred over the past 12 months regarding the library budget.

BACKGROUND

During the Washoe County Board of Commission (BCC) Fiscal Year 26 budget cycle the BCC requested that the Washoe County Library work to define the library services necessary for our community given the discussions throughout the community on the current use of our libraries. The review of services provided to the community through the library system is an important step in determining what funding is necessary and sustainable for the future.

The 2022-2025 Library Strategic plan outlines the **mission:** to connect people with information, ideas, and experiences to support an engaged community, one person at a time, with the **vision:** that all Washoe County residents benefit from the library's support of literacy and self-education.

The 2022 – 2025 Strategic plan should be the baseline for decisions related to the current service levels and the beginning point for the next five-year plan. It is anticipated that the new library director will update the strategic plan process crafted around the service levels set by the LBOT for the FY 27 timeframe.

The LBOT sets the number of locations and hours of operation through policy direction. At the September 17, 2025, meeting the Trustees discussed three options provided to them as a compilation of individual trustee feedback between August 20, 2025, and September 5, 2025, for their preferred locations, days, and hours of operation for each of the 12 branch locations. The outcome of the meeting was to begin with Option A as the starting point for creating a staffing model.

Upon receiving the direction to move forward with the selected option, the Assistant County Manager requested input from each library branch manager as well as library administration staff related to how to adequately staff the hours presented. The request of library staff was to present required staff needs to meet the days and hours in Option A for two types of library operation. Type one would be to simply have the building open

for patrons to utilize services solely related to the materials collection, a "books only" approach to providing access to our materials. Type two was to build upon the "books only" approach to include the most impactful programs for each individual branch, those programs that meet the needs of the current Mission and Vision and are well attended within the communities that the branches currently serve. Attachment A to this staff report outlines the general day to day duties of our library staff for a "books only" experience and Attachment B outlines the additional duties necessary for a "full service" library. The attachments are comprehensive lists of all activities necessary for the various popular programs but do not break out specific duties by branch based on the programmatic needs specific to each branch's patrons.

In addition to the two types of service level, based on Option A, a request was made for any efficiency upgrades that the individual branch managers felt met the spirit of Option A but would be more efficient from a staffing perspective shown as the Staff Proposed Option below.

Based on the input from the branch managers, full-time and part-time position counts were created by positions necessary to accommodate the hours for the types of service levels. The chart below outlines the numbers of full-time and part-time positions across the system for the branches only and based on branch layout not all branches are equally staffed. This does not include any positions necessary for the administration of the entire system such as the Library Director, or Collection Development Manager as examples.

As can be seen from the chart, all staffing scenarios associated with this exercise and Option A increase employee counts over current approved full time equivalent staffing. This would necessitate an increase in funding to the library system which may not be possible in the upcoming fiscal year budget process.

Based on this information, additional direction is needed from the Trustees regarding efficient and effective delivery of services for the Washoe County library system. To assist in the conversation, it may be helpful to review suggested changes to the staff proposed option and request a re-review of the necessary staffing. While looking at the difference between current scheduled hours and Option A, it appears that a driver on additional employees is potentially located in the increased hours at the Downtown, Spanish Springs, North Valleys, and Sierra View branches. By combining Option A, the current schedule and the staff proposed option a potential option may look like the option below labeled Hybrid Option.

From the exercise of reviewing Option A for the two scenarios it appears that the addition of programming for community impact, whether providing services to the core audience being young children and older adults or other programs specific to the needs of a specific branch the impact to program staffing can identified. To move from a "books only" approach generally it appears that an additional 8 supervisory/lead staff are necessary (one per branch) as well as approximately 20 various other employee types for the extended evening and weekend hours associated with Option A.

These additional employees must be a result of the hour changes as the "full service" approach is currently working for the hours of operation that are current board policy, so a solution is within reach to extend certain hours and not drastically impact the services our community has come to expect in a full-service library experience.

An alternative to the Hybrid Option would be closer to Option C from September 17, 2025, as seen below in Option C Update which could be considered a slight extension of hours but still capable of utilizing the existing staff numbers.

The client uses and needs of our facilities vary across the locations making it difficult to have a one size fits all approach; however, the current operation of the library system shows that providing a service level above a "books only" approach is possible and effective. The library system has adapted and continues to provide services to our community who are not generally calling for more, and do not seem to be calling overall for less either.

One concept to consider operationally and would need to be defined with the assistance of the Washoe County Employees Association (WCEA) and Human Resources (HR) would be to create a floating staffing pool that would be available to accomplish some level of programming above a "books only" approach and would not serve at a base branch location. This staffing pool could fill some of the gaps due to running a library system with a lean staffing model to implement rotational programming for teens and adults. Staffing the library branches appropriately for young children and senior programming at each branch supplemented with the staffing pool may be an additional efficiency enhancement that would provide targeted programming where it serves our community best.

FISCAL IMPACT

There is not currently a fiscal impact that is being presented related to this item. Additional funding above the current fiscal year approved funding would be required to fund Option A "books only", "full service" or Staff Option staffing levels identified. Future items will include fiscal notes associated with options presented to the Library Trustees.

RECOMMENDATION

It is recommended by staff that the Library Board of Trustees review the information provided, discuss the merits of the information, and provide direction to the Office of the County Manager staff for operations of the Library system for fiscal year 2027 (July 1, 2026 – June 30, 2027); and provide any additional information to consider to the Assistant County Manager for inclusion in future budget setting discussions for the Washoe County Library System.

POSSIBLE MOTION

Attachment A

TASKS FOR A "BOOKS ONLY" LIBRARY EXPERIENCE

Tasks related to books and circulation

- Create new library cards for new patrons while also explaining the services we offer and describing the layout of the branch
- Remove and check in returned items from the Automated Materials Handling machine. Assess items for damage and missing DVDs/CDs, sort everything onto a re-shelving area to be shelved, send patron requests to other branches, and stack bins when they are full of holds.
- Prepare outgoing bins for couriers. These bins hold items for patrons, non-floating collection items, and those for TS assessment.
- Checking in bins of books arriving to fill holds and new books coming from Technical Services
- Print holds list and search branch shelves for holds
- Printing hold slips and shelving holds for self-pickup
- Shelving books and AV materials according to branch guidelines
- Look for missing items (library material that is on hold, but cannot be found on the shelf)
- Check in expired holds that patrons don't pick up
- Creating and maintaining regular book displays throughout the branch (find a theme, find books in the branch that fit the theme)
- Curate special book displays coordinating with the library's Celebrations and Recognition calendar
- Refill New Books display and Lucky Day collection
- Print replacement bar codes for existing library cards, look up card numbers for patrons arriving without their cards, confirm contact information for patrons inquiring about expired cards
- Filling and maintaining hold pickup lockers (Verdi and Downtown only)
- Filling and maintaining book kiosks (Incline Village and North Valleys only)

Tasks related to collection maintenance

- Assessing returned items for damage and possible replacement
- Shelf reading and shifting
- Send damaged items to TS after changing the item status to in-transit to TS and writing a slip for each item being transferred
- Receive new magazines from Technical Services to go out on the shelf. Locate
 the old issues and ensure the status is updated so patrons can check out older
 issues.
- Updating metadata on books (moving from "new" to "old")
- Pulling weeding lists (damaged, never checked out)
- Send Lucky Day books to TS for re-distribution

Tasks related to facilities

- Cleaning (shelves, children's area, meeting room, counters, etc.)
- Meeting room setup/tear down (tables, chairs, tech, movable walls)
- Monthly fire extinguisher and flashlight checks
- Check the Zoom room throughout each hour to see if it is being used and being used properly
- Submit work orders for facilities issues (plumbing, landscaping, electrical, roof leaks, etc.)

Tasks related to technology

- Assist people with printing/copying, paying, and getting change
- Assist people logging in to public internet stations
- Troubleshoot computer issues (kids, teens, adult PCs)
- Assist patrons with Automated Materials Handler machine intake and self-checkout stations
- Update OPAC and TV slides at all branch OPACs and TVs
- Troubleshooting attend to the kiosks if they are not working
- Submit tech support tickets for tech issues throughout the branch

• Answer Book a Librarian-type questions (smart phones, laptops, tablets, ereaders, Libby, government assistance forms, creating/updating resumes, etc.) on the fly, outside of Book A Librarian appointments, while on the service desks

Miscellaneous Tasks

- Regularly walk through the building to assist patrons, monitor patron behavior and related issues, identify facility problems, pick up trash, and remove flats, etc.
- Greet patrons as they walk in the door and acknowledge them when they leave the building
- Return unaccompanied minor patrons to their grownups, explain our unattended child policy, and answer questions and address complaints relating to the policy
- Closing duties (flag, flats, shut down PCs, tidy, etc.)
- Opening duties (flag, board, boot up PCs, cash drawer)
- Input branch statistics (meeting room attendance, event attendance, outreach and class visit attendance, and all other library events)
- Attend service team meetings (YSLE, TEG, Internet, MarCom, Circ, LOVE, Managers, Admin., etc.)
- Plan and agendize service team meetings
- Supply ordering (inventory stock, find staff needs, compile order lists monthly)
- Attend County-mandated trainings (Workplace Violence, Data Sensitivity, Defensive Driving, Emergency Preparedness, Drug-Free Workplace, CyberSecurity)
- Assess and sort donated items sort, box up for Better World Books/put in bins for Friends/price for in-house book sales
- Order supplies and schedule box pickup for Better World Books
- Count and ring up money donations
- Count and ring up the copier/public printer money
- Replenish Read and Share bookshelves
- Post and record public meeting notices in accordance with NV Open Meeting Law
- Accept and sign for deliveries of business supplies and redirect items meant for other facilities but delivered here by mistake
- Intervene in patron disputes

- Write up incident reports as needed for patron behavior, policy infractions, or Law enforcement/EMS response
- Check and respond to emails
- Keep book sale areas well-stocked with products
- Talk to patrons about the posting policy if they have something to post
- Compile monthly volunteer statistics, interview and train new volunteers, and identify tasks appropriate for them to work on
- Receive office supply orders from couriers, put away
- Monitor use of the Teen Zone and restrict to teen patrons only, and explain TZ policy to adults who want to use the space
- Identify, reach out to, and build relationships with potential new community partners
- Monitor the status of local construction projects and traffic conditions to answer patron questions about them, including how they might impact their ability to access the library
- Seek out professional development training opportunities
- Create readers' advisory book lists
- Update and administer the public-facing reading lists in the library catalog
- Onboard and mentor On the Shelf contributors

Tasks related to branch supervision/PIC

- Write performance appraisals (create new goals and expectations)
- Coach staff on inter-personal issues, policies, and patron interactions
- Upload Procard receipts to SharePoint spreadsheet/folder
- Reconcile monthly Procard statements
- Submit surplus equipment requests and requests to relocate furniture and other items to other branches and County departments.
- Prepare for weekly staff meetings, create minutes for staff unable to attend meetings
- Assist at other branches for urgent staffing requests for LAIIs and supervisors
- Prepare daily schedules from master schedules, adjusting for sick leave, meetings, vacation, trainings, library events, etc.

- Monitor outdoor garbage and recycling cans, and contact the landscape crew when they need to be emptied
- Answer patron questions, concerns, and complaints about the lack of parking available during sports events held in the surrounding park, and provide the phone number where they can lodge complaints
- Write up injury reports and other Risk Management forms as needed for staff and patrons
- Answer phones and texts from staff who are taking unexpected sick leave, experiencing family and household emergencies, or are running late due to traffic/construction, etc.
- Manage part-time staff database, training assignment schedules, and monthly topics to be covered
- Print out and track database training assignments, then return completed assignments to staff

Annual or Biannual Tasks

- Hand out tax forms and instruction booklets, and assist patrons with locating and printing less commonly used forms during tax season
- Answer questions about the availability of tax forms and community resources providing tax assistance during tax season
- Prepare training presentations for Staff Day sessions or library conferences (e.g., NLA, ALA, PLA, YALSA).
- Direct patrons to polling places, both inside the branch and at other locations, during election season, and explain why we cannot accept their drop-off ballots

ADDITIONAL TASKS FOR A "FULL SERVICE" LIBRARY EXPERIENCE

Tasks related to programs and reference

- Prep for family story time, toddler time, baby story time-find appropriate books, fingerplays, songs, and create song sheets for the audience to participate
- Non-story-time program preparation (Camp STEAM, QUAD, Pokémon Party, Teen Tuesday, Crafternoon, Cricut, etc.)
- Book a Librarian session Help patrons one-on-one complete online job applications, file for unemployment, obtain a Real ID, set up an email address, and apply for government assistance, among other services.
- Research new program ideas
- Give readers advisory advice to parents seeking books for a specific assignment, particular grade, and/or Accelerated Reader level, or interest for avid young readers, as well as reluctant readers
- Maintain book club alongside multiple partnerships, communicate with regular attendees, and promote to new attendees
- Answer phone calls, provide directions, place holds, and more.
- Create digital slides, posters, and social media posts to run on OPACs, TVs, and print out for branch bulletin boards
- Plan, research, and read children's books in preparation for writing On the Kids'
 Shelf scripts that include a corresponding literary tip and activity, to be read for radio programming with KUNR partnership



I am writing to express my deep concern about the possible closure of The Verdi Community Library. For generations, this library has been more than a building filled with books—it has been the beating heart of our community, a place where people of all ages gather to learn, connect, and grow. Verdi is a community library and serves as a place to pick up current bestsellers, to research local history, or to gain access to the entire Washoe County Library System.

For children, the library is often the first place where they discover the joy of reading. Wednesdays are the only time that a public library program is available to Verdi kids on the early release day which is the "mini makers" where kids can come and make a craft or do another activity in a safe space. My grandchildren look forward to this event every week. This allows children to interact with students of all ages. They make new friends and are excited to reserve books. Social interaction is very important for children as well as adults. The Washoe County Library staff is very patient and work hard to provide creative activities during this time.

It has been brought to my attention that the Board of Trustees are recommending a Bookmobile to be brought in. There is no need for a Bookmobile when we already have a physical library with a plethora of reading options. We are also grateful for the opportunity to reserve books from other county libraries to pick up at The Verdi Community Library. This provides us with even more library opportunities in our community.

For adults, it provides opportunities for lifelong learning, job searches, internet access, and community programs. For seniors, it is a welcoming space that combats isolation and keeps them engaged. There are many residents in Verdi who do not have transportation to take them to other libraries in Washoe County.

Closing The Verdi Community Library would mean taking away opportunities, knowledge, and connection from every resident of our town. Especially in a time when access to *reliable* information and *affordable* resources is more important than ever, our library continues to serve as an equalizer, giving everyone—regardless of background—access to the tools they need to thrive.

Verdi has grown tremendously in the last decade and is continuing to grow. We need to keep our little library in our community.

*Two large housing projects will bring hundreds of new homes to Verdi over the next few years. Reno Land Development Company, will erect 273 single-family homes at its Meridian 120 north project near Boomtown-Garson Road. And D.R. Horton will build 324 homes at West Meadows Estates off Highway 40.

I urge you to reconsider any plans that would reduce or eliminate funding for The Verdi Community Library. Instead, I encourage exploring solutions that invest in its future. Supporting our library is not just about preserving the past; it is about ensuring the success, education, and well-being of our community for years to come.




I am very opposed to the idea of closing this library. The Verdi area has so few services as it is from the County and the City, that it's hard to believe one of the few services out here would be taken away!

Good evening. My name is Andrew Maurins, I'm an LAII at the South Valleys branch, and I'd like for the following to be added to the record, please.

Banned Books Week is next week, and I'd like to use the opportunity to give some credit where it's due. I've seen select books be brought before the Board of Trustees to be either banned outright, or moved to a different section of a library branch several times. But each time I've seen this happen, the Trustees have opted not to do either. And in the vast majority of such cases, that's the right decision.

It's not an easy thing to constantly be the recipients of impassioned pleas from people who support book bans and censorship. But the Trustees have correctly recognized that intellectual freedom is paramount, and that blanket bans are not a substitute for thoughtful, individual choices. They've seen through all the noise, and they understand that free people read freely.

The freedom to read is natural, spontaneous, and requires no instruction (apart from a caregiver's involvement in their child's reading choices, which we always encourage). Censorship, by contrast, requires constant effort to impose, which speaks to just how broadly unpopular it truly is with a majority of Americans.

So thank you to each of the Trustees for upholding the values that every library stakeholder — and every American — should cherish. I hope we can continue to work together to protect these values going forward.



I am very disappointed at the suggestion of closing the Verdi Library. It is the best meeting place in Verdi for our public meetings, fairly centrally located, and has enough space for expansion. West Reno/Verdi public are lucky to use this public meeting space and as a resource for research.

The location next to the Verdi Elementary School is perfect for classes to walk to the library. Why should the children and other users lose this foundational resource to education? The cost to bus students to the Northwest Library, Robb Drive, would not be cost effective.

The existing library is a good, but will be an inadequate start for all the new subdivisions that are projected for the Verdi area. Before the library was built the school cafeteria was a miserable meeting place; to my knowledge, Verdi Elementary still does not have an auditorium or large meeting room.

As a retired teacher, I have never heard of this option to close a library and very disgusted at the suggestion since it has taken years to build the facility and stock it with a basic selection of books. Verdi Library functions as a school library and a public meeting place. Northwest Reno/Verdi used Verdi Library when the Clinton/Obama vote took place because of lack of public meeting space.

Nationwide, children in the elementary schools (4th grade) have the lowest reading scores in the nation. As a member of our Washoe County community, I am increasingly concerned with the proposed changes that include cuts to services to our Verdi Public Library, specifically the Option A plan discussed at the 9/17/25 LBOT meeting. I have worked for WCPLS and am currently a Washoe County School District Library staff member, so I have a tailored and unique position and experience to speak to the issues with your plans and proposals.

First and foremost, are the Verdi community members less important than any other WCPLS patrons and Washoe County taxpayers? These proposed cuts suggest that you think so. Closing down days, hours, or providing a bookmobile instead of in-person services where a physical library exists are not valid solutions to a budget issue. Our Verdi patrons are paying tax dollars for these services, and **it is your job to provide those services.**

I am an Elementary School Librarian for Washoe County School District and I realize what an incredible service the Verdi School Librarian provides the community. Beyond the partnership that she and I share as Elementary School Librarians, I am a former Washoe County Public Library Systems employee and used to staff the Verdi Public Library on a weekly basis from the Northwest Reno Library. The time that I spent in Verdi is something that I truly cherish because the community welcomes and values library staff so warmly. These patrons are so grateful to the library for being open and being there to help them. Connecting with people is so important. *Make no mistake that in-person hours is the only practical and possible way to make that connection happen*.

The Verdi Public Library serves the wonderful community of Verdi where no other branch does. Cutting any of the current three service days would limit patrons' access and services, especially with the 2,000 new homes going in, and all the growth that is happening in that area.

Wednesday service hours are especially vital to the community because the Verdi Public Library serves students through a program called Mini-Makers. This student-focused event brings families into the library for crafts, STEAM, and other unique and *free* community experiences. These experiences create engaged and informed citizens.

The students of Verdi Elementary School *are* patrons of the Washoe County Public Library system and are a vital point of service. Being open to the community three afternoons a week provides important services to students and the community such as: hold pick up, browsing and circulating materials for all ages, free park pass access, computer and internet access, the nature room and trails, and collaboration with the Verdi school library with programs such as the Summer Reading Challenge.

Another significant service that the Verdi Public Library provides is lockers to serve less able-bodied or immune compromised patrons, or those who cannot attend public hours. The lockers are a unique feature in that they provide all-hour capacity for those who cannot make in-person hours, but they need to be filled reliably, by WCPLS staff. This kind of service for the community requires staff to check-in and process holds for these locker pick ups on a regular basis.

Next, bookmobiles are meant to service rural areas that lie outside of communities where library infrastructure is already in place. Providing the Bookmobile to Verdi when there is a beautiful branch available is an absolute waste of resources that are valued by the community.

Finally, there is the issue of partnership staffing of the Verdi Public Library. First and foremost, for safety, it is mandated that <u>two</u> Washoe County Public Library Services employees staff public hours at Verdi. Next, the Board cannot ask Washoe County School District librarians to staff the public hours. We are not WCPLS employees! Who would pay us? Beyond that simple fact, school district librarians already work full-time serving the students who utilize their school libraries. The Verdi Public Library is meant to be a collaboration with

I have been a teacher in Washoe County School District for 25 years and have seen and experienced what school district libraries typically offer. Being at Verdi Elementary for the past 11 years, I have come to appreciate so many special things... one of them is our shared public library.

I understand that Washoe County Library faces deep budget cuts and that Verdi's staffed public after-school hours are in jeopardy. These cuts would mean no programs, no county librarian support, and no access to the broader county library system. This would be such a tragedy for the Verdi Community. We stress the importance of early intervention and getting books into the hands of children learning to read. Many families who visit the library after school would lose access to books at their child's reading level, which puts them at a disadvantage compared to other children in the Reno area with access to these services. Cutting public library hours would limit our community as a whole— families, teachers, and students — would lose the systemwide resources we rely on every day.

We know that you are considering other options. A bookmobile is not the answer, as we have the building already. Let's continue to use this library that many Verdi residents help to fund and build. Another option suggested is to have our school librarian stay after school to work during public access hours. Mrs. Cook already works here full time, and if the public library requires at least two people to staff the building during public hours for safety concerns, her safety should also be respected.


I address this email to all those involved with the decision about the future of the Verdi Library.




Cutting staffed hours would take away equitable access to the Washoe County Library System for our community. Verdi deserves the same opportunities and resources as every other neighborhood.
